Dear Mr Weisberg,

Thank you very much for taking the time to talk to me. I hope that your court case the following day went well.

As I explained on the phone we are hoping to be able to do a programme examining the role, if any, played by Lee Harvey Oswald in the death of John F. Kennedy. We are especially interested in examining both sides of the issue: both the evidence which tends to incriminate him and that which tends to point to his innocence. We are anxious to avoid getting too closely involved in criticising the Warren Commission, the FBI or any other agency which may have obstructed the course of justice. Interesting though this is, we are keener to get back to looking at what happened in Dealey Plaza. Obviously much of the evidence is tainted, but I feel there is enough material to build respectable cases for and against Oswald having committed the crime. It is our wish to attempt to do this by presenting the testimony of those people who were there at the time or of forensic and other experts who are qualified to examine the physical evidence.

Undoubtedly you are one of the premier authorities on the subject and I hope that all being well we should be able to visit you for a discussion face-to-face sometime in the New Year. In the meantime, if any witnesses spring to mind who would be able to help us; particularly in developing arguments which exonerate Lee Harvey Oswald, I would be most grateful if you would drop me a line or call me collect here at London Weekend Television on 01-261 3018. In our phone conversation you mentioned the police outriders, one of whom saw Connally hit by a separate bullet.
