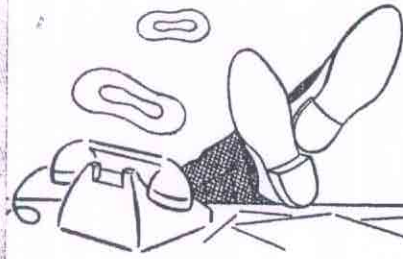
Dear Mr. Weisberg:

Dear Mr. Weisberg:

Thanks for your letter of acknowledgement. I have edited many newspapers, books & trade issues.

I worked for King Bros., Inc., 208 N. Calvert St., Balto. Md., for ten years before retiring as proof-reader. They are most efficient in printing having done the State of Maryland & the Commonwealth of Virginia's laws until recently. The man to see there is Howard King, son of their former president.

King Bros. was established about 1847. There you can have hot or cold type. It is cheaper doing a book in cold type. As to the rates or prices I have no idea. That was out of my realm.

You are certainly indefatigable judging from the 5 books you have already printed. Have two books myself unprinted on account of rising costs in the printing field. Wrote both in my journeys through New Guinea and the Invasion at Leyte, P.I. in 1944.
