Dear Mr. Meisel,

You do not say where you will be or will be staying. I ~~presume~~ presume Washington or that area. If you decide to stay in Frederick, as some planning to be in Washington do not to be there at night, the Red Horse Inn, which is on the road to DC, is probably the best for anyone coming here.

As of now I have no extra medical appointments that week of January. If all you want to do is look at my files, most of which are in the basement, that does not require me or take much time. You may also use our copier if you'd like.

Normally I leave quite early for most people all mornings except Sunday. Mondays Wednesdays and Fridays in addition to the little walking possible for me I then have a blood test and then physical therapy. But I'm usually home by 9.

Because I am up so early I must retire early and aim for being abed by 6.

If you would find it more convenient to stay in Frederick I suggest you make your reservations as soon as you can, as I suppose may be true for the entire area, because they are not infrequently filled up. If you want to talk to me and if you'd like I can join you for breakfast and we can talk then. Or you can come here, but my wife will not be able to offer to serve you. She is too tired. You can, however, help yourselves to cereal here. When we go out to lunch we can go anyplace not inaccessible to me but when we chose every day but Monday we go to a fine oriental restaurant. Mondays and other days for those who do not like oriental food there is a fine nearby restaurant with excellent crab cakes, if you like them.

From DC you'll be on I270. That identification disappears at Frederick. The same road continues as US15N and US40W. Stay on that, and avoid I 70 in particular, until you get to where US 40W leaves, at W, Patrick St. Cross that bridge and then come off. Before you get to that cloverleaf you'll see the second local Holiday Inn. You will go under the road you've left and go to it. Turn right past it on Baughman's lane to the first crossroad, Hookstown Road. Turn left on it for about 5-6 minutes. You'll then have just started up the mountain and will be in Hookstown. About 4-5 city blocks uphill, no cross streets before then, you'll see the Old Receiver Road sign on the right. Turn right for about two city blocks and you'll see, on the right, our large box with 7627 on it. Come to the house through the carport, to the kitchen door. I'll take a reasonable amount of time if you'd like but please remember that I'm old, frailier than I seem and am pushing to get all I can on paper for our history. You'll see the volume.
