

Introduction

On November 22, 1963, America's thirty-fifth president of the United States (*John Fitzgerald Kennedy*) was murdered as he rode in an open car through the streets of Dallas, Texas. In the hours, days, months and even years that followed the assassination there grew one of the most notorious mysteries of the 20th century. For every question that was answered there were at least a dozen more new questions left unanswered. It seemed that all at once, every level of both the local and federal law enforcement agencies involved in the investigation that was to follow, had now become delinquent in their duties to pursue the available facts and evidence in the case. Witnesses that had tried to come forward with what they had seen or heard were intimidated into keeping quiet or ignored altogether. Testimonies that lead to other participants in the assassination were either altered or had never found their way into the records at all. Evidence that was present in and around the murder scene was either collected and never to resurface again or was able to somehow magically change form and become something else entirely. Normal investigative procedures by the local police and the various federal government agencies were not being followed both before and after the murder of President Kennedy. Medical records were destroyed and common everyday autopsy protocols were either forgotten or disregarded. For not even in death was our murdered President to be given his right to a thorough and professional handling of his wounds as to make known what actually happened to him during his last few seconds of life. Even before the shots rang out in Dallas, the setting of the stage for President Kennedy's murder

was already taking place. An unnecessary motorcade route had been planned allowing the President's car to be slowed down to a near standstill in an area where assassins were later able to ambush him. The president's protection had been stripped away and even when a warning was dispatched throughout the FBI that an impending attack was indeed going to take place during the President's trip through Dallas, the warning was ignored and not passed along through the proper channels.

Any one of the many things that faltered both before, during and after the President's murder could be looked upon as mere coincidence or possibly excused as just gross human error when singled out by themselves, but when all these things are examined as a whole there has never been so much evidence that pointed to a conspiracy than in the case of the assassination of President John F. Kennedy. But yet those individuals who were appointed by the newly sworn President of the United States through his establishing a Commission to investigate the assassination, had almost immediately laid claim to the notion that there wasn't any evidence to support a conspiracy and that the assassination had been the work of only one man. For the United States Government in all its capabilities to have conducted such a poor and biased inquiry into the facts of this one single murder case is highly suspect to nearly every American who has gained even the slightest knowledge of the events surrounding the assassination. If not for the work and dedication of a handful of investigators to seek out the truth about what really happened to President John F. Kennedy as he rode through Dealy Plaza, turning down Elm Street towards the Triple Underpass on that warm sunny November day in 1963, most Americans would still be oblivious to the true facts of the case. It's unimaginable for me to think that those dedicated investigative researchers I speak of, despite the many walls and obstacles that they've had to overcome, have been able to do what our government has been incapable or unwilling to do for nearly four decades. And to do so with not the help of the government's vast resources and cooperation, but to have done so with their own limited time and resources. For in nearly every incident our government has blocked the efforts of those who have tried to expose the truth about the assassination of President Kennedy. It boggles the human mind to think that our government's law enforcement agencies can take on such an undaunted task as searching the ocean floor for a downed jet liner only to find it and bring it up piece by piece until they not only have enough information to tell why it went down, if there was an explosion, where on the plane it exploded, whether an explosive device was used, how it got on board, where the material was purchased to make the device, how it was

built and most of all by whom. And let the record show that no expense has ever been spared to seek out those individuals believed to be involved in any way of their suspected crimes. But in the case concerning the murder of President John Fitzgerald Kennedy, you will find that not one fraction of this same type of determination and effort was ever made to sincerely bring about any kind of real justice sought for this magnitude of crime not only against our murdered president, but also against the people of this nation who he represented. When viewing the facts of this case, one has to wonder how it was that a crime that should have demanded the all out efforts of this nations law enforcement agencies to leave no stoned unturned wound up being nothing more than an obvious attempt to conceal the true facts of the case and to protect those who were involved in this cold blooded crime of the century.

And let us say shame on those who have taken the easy way out by admitting that they had withheld what they knew in order to spare the Kennedy family of any more pain than what they have already endured. What greater pain or injustice could one inflict on someone else than to allow the murderers of his or her family member to go unchallenged and unpunished. Who of us has honestly ever really heard of a murder victim's loved ones saying that they didn't want their slain family member's killer(s) held accountable for their terrible deed and brought to justice because it would be to painful of a process for the remaining family to go through? What are we to think when those who were supposed to be closest to the President will make such admissions that he or she told the FBI what they wanted to hear and that the family had suffered enough? To take such a position is not only an injustice to the memory of President John F. Kennedy, but it's also a disgrace for what he stood for and was in the end willing to die for.

One of the tragedy's after nearly four decades is that most Americans are unaware of the quality of the evidence that has been uncovered by the various researchers to date and that most likely if presented all together in a court of law that the spirit of John Fitzgerald Kennedy would emerge victorious over the very government he presided over at the time of his death. Moreover, I believe it can be shown that in accordance with our own current standards of law that in response to the overwhelming evidence, a guilty verdict could be obtained against the United States Government for it's involvement (*through it's own agencies*) for the planning and execution

of President John F. Kennedy, along with the mass cover-up that has followed. The issue here is accountability!

This book is dedicated to all those who have added to the endless efforts to expose what really happened to President Kennedy on November 22, 1963. It may be too late to seek out all those who participated in the planning and execution of the murder of President Kennedy, but I believe that it's not too late to hold the one major culprit accountable for its institutions that were responsible for not only causing and /or allowing the murder to take place, but also for purposely covering up the facts and distorting the evidence as to allow those individuals involved to remain free to this day. It will be this author's intention to present the available evidence as the many researchers, including myself, have provided it as of the time of this writing in order to allow the American Public to stand in judgment of their government's involvement in the murder of the thirty-fifth President of the United States. It's the hopes of this author to allow the spirit of John F. Kennedy a voice to be heard with and to be given his day in the courts of the American public's opinion. To make those individuals aware that their deeds did not go unnoticed and that those responsible for protecting them can be held accountable from the evidence in accordance with our current standards of law. Not to overwhelm the reader with a mountain of evidence, but to point out enough of the facts to show that something far more sinister than a lone gunman fable was at work in the elimination of our 35th President of the United States. To let the record not only speak for itself by letting the chips fall where they may, but to also show the reader that the constant denials of wrong doings by our government through its agencies despite the undeniable facts that tend to consistently show otherwise, compounded by the inexcusable lack of interest to correct the official record and to seek out those who were guilty that are still at large, can be as telling in itself as the ultimate signed confession of guilt.
