Hello again, I hope this letter finds you and Lillian doing reasonably well.

Last year, one of my students, Authar Martin, shared the content of your letter to him with me. Authar gave me the xeroxed copies of Oswald's room at 1026 N.

Beckley and Gene Danish's photographer's credit that you so kindly provided, to me.

They will find their way into a 35th Anniversary Kennedy Commemorative Exhibit in the the Cooper City High School library on November 23rd and 24th, 1998. If our project team isn't able to finish the exhibit materials by then, my Future Studies class of the second semester of this academic year (The Warren Commission Report and the Assassination of President John F. - (1) To display a commemorative exhibit of the administration of the thirty-fifth President of the United States on the 35th anniversary of President John F. Kennedy's assassination
- (2) To provide a detailed analysis and examination of the major conclusions of the Warren Commission Report in the light of U.S. Government document disclosures over the past thirty-five years, especially those since the passage of Public Law 102-526, The President John F. Kennedy Assassination Records Collection Act of 1992, and also specific Civil Actions filed under the U.S. Freedom of Information Act of 1966 (5 U.S.C. 552), as amended 1974
- (3) A: To create an opportunity for exhibit viewers to draw their own conclusions regarding whether or not there has been enough official evidence to support the idea that a preconceived plan to take Kennedy's life existed and,
 - B: That the crime was never truly investigated, thus making it possible to successfully cover-up the genuine facts regarding the assassination
- (4) Finally, to provide a compelling explanation for an otherwise needless thirty-five year controversy regarding the murder of President Kennedy, it's Cold War context, and it's ultimate significance as a harbinger of permanent social and cultural change in American society
