Dear Harold,

I have about 42 pages of letters about the John F. Kennedy assassination re-investigation that is beginning to very slowly reform in Congress. Indeed, I have letters from Sen. Church, Sen. R. Schweiker, and Sen. Dan Inouye! My own efforts have been to draft an investigator's brief for the reinvestigation of the assassination, which focuses attention on the F.B.I. coverup in Dallas'and in Washington, D.C. You were certainly right about that one!

My brief lists some very detailed conspiracy theories involving a network of ex-C.I.A. people, F.B.I. informants, and right wing anti-Castro groups in Dallas, New Orleans, and Miami. The famous southern air transport system of the C.I.A. figures in rather large in my synopsis. The people I think require scrutiny include Cabell, Donovan, and Nixon.

My investigative work began in 1974 and carried on into 1976, when I wrote to Sen. Howard Baker about the possibility that the O.S.S. had killed A. Hitler in 1945. I hope to work for the new intelligence committee and I have supplied an application vita and been nominated by  $Re_p$ . Les Aspin, my friend here in Wisconsin. I am sure you know what he has been doing so many years in Congress in an effort to cut our defense spending? Certainly, Les is a very intelligent man and may be the key to the re-investigation of the Kennedy assassination? I also am impressed with  $Re_p$ . T. Downing of Virginia and Mike Mansfield.
