I'm writing you about a record I'll be sending to you although I have not yet read the record.

This isn't as odd as it may seen. It is part of my adjustment to the realities of my life, as I'll explain.

Exercise is now more important than ever for me and with so large a place to care for and so much to rescue from the wildness that set in when I was not able to prevent it I do as much work as I can outside. Some things I can do rather well, others not well. I don't go out a work a few minutes and call that exercise. I work up a good sweat, trying to estimate how much will not be too much. When I stop I rest, something the opposite of what athletes call warning down, but I don't stop abruptly. I move around a bit. When I rest I read. Most of this reading is related to the FOIA cases, somethimes it is FHI records. But they attract my attention because of FOIA involvement. However, when I have a Section for checking I read the entire Section as soon as I can. All of it, and I'm now keeping track of which.

Today's reading included Section 126 of 62-109060. In it I came upon a long DeLoach memo of a visit from Jack Anderson as soon as JA returned from a long interview with Garrison. He was impressed. It was in 4/67. As soon as I saw that Garrison had impressed him and the date and was aware of the length I suspended reading until a copy is made so I might mark it without having to read it more than once. I also indicated a copy for you.

The reason is because it suddenly occured to me that in order to offset what JA indicated might be favorable column attention to Carrison DeLoach might have arranged for the Castro kickback-Mafia leak to Anderson.

If you recall or can easily find the date of that leak I'd be interested.

Remember, the lawyer who represented the mobsters had formerly worked for DJ, I think Criminal Division.

The timing of that leak always fascinated me and I was always of the opinion that it had been mrranged as a manipulation. Not just a favor or a story but for a purpose.

If Anderson were going to write favorably about Garrison or what is not impossible he led De Loach to believe it so DeLoach would feed him, there then is motive for the leak, an effective disinformation so far as the assassination is concerned.

As well as a blast at the CIA, which Hoover never liked and may have been feuding with then.

After you read it let me know what you think.

Before going to bed last night I got curious about the DeLoach 4/4/67 memo, Serial 5075, about which I had written you on a hunch without having read it. And I did read it. While it does not confirm my suspicion, it is in accord with it and adds the detail of when and how LEJ came to believe the caption, what he told Leo Janus and others. The FHI told him, DeLaoch to Watson, a normal channel. It was through Watson, for example, that LEJ was given the propaganda about the critics, which obviated the FEI's need to confront such fact as I had by then published.

I have several other Sections, perhaps those that immediately follow this man one, set aside to read while I rest after working. The forecast for an unusually hot day indicates I'll be doing this several times today so before long I'll have gone through them. If there is anything relevant I'll send you a copy.

I can't say how soon but it won't be very long. Idl can't stand at the machine for as long as before and there is an accumulation of copying for appeals. If we do not have to turn the air conditioning on it may be too hot for use of the machine today and on other hot days, the immediate forecast.

It is rather a coincidence that I find this just when Jim and I earlier this week discussed a use for this kind of information I have been thinking about for some time. Because I have this possible use I'd prefer that you not pass this along. Meanwhile, that will give some time in which other relevant records may come to my attention. There is a reference in this one I'll ask Ras to see if she can find when she is here in two days.

In the course of going over as many records as I have I believe I have spotted some biggare FEI filing of which I tell you in case I've forgotten. I've started to keep a file of numbers, which I believe is why I asked you for any identifications you may have. These can be useful in breaking other records out.

94 seems to be the file in which they hide their leaks. It is called research matters. Laboratory research matters is 80. This is where they have Garrison records hidden. They have a copy who had been assigned to Garrison listed in a 67 file, which if for employment-type personnel investigations. There is a number of files in the 60s that they also use, captioned various kinds of "administrative" matters. They also use old files, like the security investigation file on Bud for records on him, ditto on me when I was not a candidate for government employment. I'me even under bank-robbery.

I've also found one Trafficante record, almost entirely obliterated but with a name, Regano, apparently a source, not removed. It is to be copied and if there is anything of interest in it I'll send you one. My recollection is that virtually nothing remained after the obliterations, which were double-layered.

Anderson describes Garrison as a very convincing talker who has considerable facts at his disposal. Anderson now believes there is some authenticity to Garrison's claims and future plans. Garrison told AndersonS that he will undoubtedly hold a full-scale trial within six months. Basically, Garrison told Anderson that the entire assassination plot stemmed from David W. Ferrie, who was the genius and mastermind of the entire thing, and with Clay Shaw genius and mastermind of the entire thing, and with Clay Shaw, who was in the beginning subsidized by the Central Intelligence Agency. Garrison has facts, as well as witnesses, according to Anderson, to prove that Lee Harvey Oswald came to the attention of Ferrie and Shaw when Oswald first arrived in New Oricans, H At that point, both Ferrie and Shaw recognized the fact that Oswald was a former marine, had had lengthy experience in the Soviet: Union, was married to a Soviet citizen, and therefore in had tids, and background which would lend themselves to gaining easy access to Cuba. been rented by an anti-Castro organization. Ferrie and Shaw also conceived the idea of sending Oswald to Mexico in a fake attempt to obtain permission to re-enter the Soviet Union. Garrison, according to Anderson, can prove that Oswald did this merely to establish a good atmosphere so that he could gain ready access to Cuba.

Garrison claims that it was at this point that Oswald became disillusioned and refused to go through with the plot to assassinate castro. Upon returning to New Orleans from Mexico, Oswald advised both Ferrie and Shaw that he would not go through with their plans. Shaw and Ferrie, being guided by several Cubans in their midst, then conceived the idea (mostly because of the flasco at the Bay of Pigs) of assassinating President Kennedy. Ferrie and Shaw believed that Oswald could be the "patsy" and instructed him to go to Dallas for the purpose of the assassination.

They also engineered the idea of him buying the gun under the name of A. J. Hidell, and the use of the mails in procuring this gun so that it would be an open, public record which could be traced to Oswald. They additionally told Oswald that he should keep certain papers in his possession which would trace back to the gun.

On the day of the assassination, Ferrie traveled to Houston, allegedly for the purpose of ice skating. Witnesses at the ice skating rink remember Ferrie as being at the rink and have indicated to Garrison that Ferrie, while he did not ice skate, did stand near a pay telephone at all times on the day of 11/22/63.

Garrison also has witnesses who will testify that Jack Ruby was the eyes and ears for Ferrie at all times. Ruby sent two of his people to Houston so that, upon the success of the assassination attempt, these two people could use a flocal pay phone to advise Ferrie of the success of the plot. Garrison claims that a long distance phone call from Dallas to Houston could, of course, have been traced; hence the desirability of using the local phone. Anderson stated that Ruby was definitely in on the plot and was later instructed by Ferrie and Shaw to take care of Oswald.

Anderson next sprang the "Sixty-four dollar question." He stated that at the close of Garrison's six-hour recitation of facts, he (Anderson) was of the opinion that Garrison was not only sincere, but very convincing. Anderson stated that Garrison firmly believed his facts. Anderson then told me that he bluntly asked Garrison why Garrison had not given all these convincing facts to the FBI, whereupon Garrison replied, "I got started off on the wrong foot with the FBI." Garrison added, "I would be more than willing to give the FBI everything I have and let them finish the investigation if they so desire."

Anderson told me that he, of course, is now in a position to contact Garrison and indicate that the FBI will or will not take over this case. I told Anderson that the FBI would not under any circumstances take over the case. I stated that Garrison had made it quite plain that he did not want the cooperation of the FBI and, as a matter of fact, Garrison had threatened to put handcuffs on any of our agents who approached Whim for information.

I also told Anderson that, while we of course would accept any information that was voluntarily given to us, we lat the same time would not take over Garrison's "dirty laundry."

Anderson told me that if the Bureau had any change of policy in the above regard he would appreciate knowing about it. I told him we would keep his offer in mind; however, there definitely would be no change of policy.  $\Gamma_{1}$ Ana harration

Anderson also told me that he had discussed this entire matter with Goorge Christian, the President's Press Secretary, at the White House. He stated that Christian was also convinced that there must be some truth to Garrison's allegations. Christian told Anderson to get in touch with the FBI. Anderson stated, he had already been planning to do this, but that he now especially wanted to advise us of the full facts because of Christian's request.

Watson stated the President felt that CIA had had something to do with this plot. Watson requested that any further information we could furnish Internet (in NCY.

I reminded Watson that the Director had sent over to the White House some weeks back all the information in our possession in connection with CIA's attempts to use former agent Robert Maheu and his private detective outfit in contacts with Sam Giancana and other hoodlums, relative to fostering a plot to assassinate Castro. Watson stated this was true and he remembered our memorandum in this regard, but that if we had anything else we should by all means forward it to the White House. I told him we had no further information in this regard.
