A confidential informant told me that LANZA was possibly connected with LUIS LAGORIO, a contractor in San Francisco and Redwood City. The name LUIS LAGORIO does not appear in any of the current San Francisco Bay area telephon drectories. The informant also thought LANZA was with ANTONIO CORNERO (died in 1935) in connection with the gambling ship <u>Rex</u> in Santa Monica Bay in the late 1830's. According to "The Green Felt Jungle" (Reid and Demaris, pp. 63-66) COENERO was a U.S. Naval Intelligence agent in Central and South America in World War II. In the 1950's he promoted and partially built the Stardust Hotel in Las Vegas. The informant has been "too busy" to provide further information since the one discussion on the subject.

An alleged hood named LANZA of California is pictured in Life (1 Sept. 1967, p. 20).

The New Orleans Times-Picayone of 28 Jan. 1968 (p. 2) records the death of Mrs. CARLEEN MOLEY LANZA on 27 January. She was 82 years old, a native of Italy, and a resident of New Orleans for 70 years. Husband: BEN LANZA (deceased). Sons: <u>ANTHONY, MIKE</u> (deceased), JOSEPH, CARLO, SAM, and LUKE (deceased). Daughters: Mrs. GERALDINE FAST, Mrs. ANNA LANZA GUARINO, Mrs. MARY LUMETTA, Mrs. ROSA PECORA, and Mrs. BENA TOZEL. The employees of several companies were invited to the funeral. Whether or not the late CARLEEN LANZA was the mother of ANTHONY and MIKE LANZA of Sam Francisco, I have not determined. I also do not know if MIME LANZA of Sam Francisco is living. JOSEPH (Socks) LANZA (relationship unknown) was connected with organized crime and Tammany Hall in New York (see NY Times Index: 1931, 1933-1938, 1940-1944, 1952, and 1954).

The building at 559 Washington is about 30 feet by 120 feet. In addition to the office of ANTHONY LANZA it contains the offices of FALLON, HANGREAVES, and BIXBY, attorneys, and the office of NORMAN C. WILLEY, public accountant.
