In this I am telling you, if you did not know, that Random House knew before you submitted your manuscript what it inevitably would have to be. Between that and the disappointing sales of Case Closed I can only wonder whey they publisher your book. They had every reason to know that what did happen to it would happen to it.

For their own reasons, whatever they were, they helped you do to yourself Wthat you have done to yourself. If its bombing does not tell you what you have done to yourself, read my current NEVER AGAIN!

You have a great talent and a greater ego.

You have also played Faust to Schiller's Mephisto.

As long as that ego controls you your talen Vis wasted.

History and novels are not alike, as you have said and history does not lie, as you also have said. It is those who write lies who do the lying, not history.

There is nothing wrong with making money but there is everything wrong in serious writing to do that writing for money. The money should be earned by the writing.

Pretended mind-reading and ESP, both from the grave, is not serious writing and as you have seen, it does not make money.

Nor does defaming people, as you did to Marina.

It is awkward seeming to be avuncular to a man of seventy but I do suggest tow you that in what writing you now do you remember, as I once told you, that we are both here and free by the accident of birth and that, as Frost wrote, we were born with promises to keep in the miles we go before we sleep.

Having tried to do this and looking back on about ten more years that you can I assure that it makes for a god feeling, particularly for a writer.

I hope that in your future writing you will control that ego and go back to your earlier writing and start trying to keep those promises again.
