And Ruby said, 'That is good enough for me. What is it you want to know?'" (Burrings, Volume III, p. 67, in regard to the afternoon of November 24, 1963.)

"His file was in the hands of FBI Agent James P. Hosty, Jr., ...an outspoken admirer of John F. Kennedy." (Death of A President, p. 32)

FBI Agent James P. Hosty, Jr., may indeed have been "an outspoken admirer of John F. Kennedy," but he was also a friend and "bridge-playing buddy" of Robert Surrey, rightwing fanatic, aide to General Edwin A. Walker, and publisher of the scurrilous anti-Kennedy "Wanted for Treason" pamphlets distributed in the streets of Dallas before and during the motorcade.

"Leaves Depository by front entrance, pausing to tell NBC's Robert MacNeil he can find a phone inside; thinks MacNeil is a Secret Service man." (Death of A President, p. 279, interview with MacNeil, June 15, 1965.)

This is an interesting allegation. In his interrogation with the Dallas authorities, LHO stated that a man with a "crewsut" ran up the stairs of the Depository and showed him (Oswald) his "book." In addition the man identified himself to Oswald as a Secret Service man. It is now stated by you that this man with the "crew cut" was Robert MacNeil of NBC. Here, then, is a most crucial witness. Here is a witness who can state definitively the time, exit time, of LHO from the TSBDB. (Concussion time for this event is 12:33pm, CST.) LHO, by mentioning this man, hoped no doubt to use him as a witness in his behalf. Yet, the Warren Commission did NOT call Mr. MacNeil; nor so far as I am able to discover did the FBI interview Mr. MacNeil in this regard. One is really made to wonder how and why Mr. MacNeil (allegedly a neophyte) kept this story to himself for nearly ~~two~~ two years? Surely Mr. MacNeil would have made a most convincing witness for both the FBI and the Warren Commission, in order to back up the Government's contention that LHO left the TSBDB at 12:33pm. The fact that he was not so called or interviewed gives credence to LHO's possible use of the "crewsut" man as a defense witness, if he (Lee Oswald) had lived to stand trial.

It is also difficult for me to believe that a man as accustomed as Lee Oswald to both American and Russian police agencies, should misconstrue the words "NBC" for "Secret Service."
