On March 17, after a hasty reading of the HSCA medical panel testimony of Dr. Ebersole, not having your address, I wrote Gary aguilar in haste, asking him to communicate my concern to you. Gary was thou hful. He'd sent me the trascript of that testimony and the first time I had the chance, I read it. Then when I could 1 thought about it further. I then wrote him again, both times without response. I think he misunderstood my purpose.
