New Orleans files reveal that this office obtained one 16 mm. duplicate film print of silent movie taken by WWL-TV of OSWALD distributing leaflets on 8/16/63 in front of International Trade Mart, 124 Camp St., New Orleans. This duplicate film obtained from MILTON LeBLANC, Pan American Films, 822 N. Rampart St., New Orleans, on 12/3/63 and sent to Bureau by letter dated 2/4/64. Bureau is referred to pages 425 and 426 of report of SA WARREN C. DeBRUEYS dated 12/8/63 at Dallas.

New Orleans files reveal that one 16 mm. duplicate film print of silent movies taken by WDSU-TV of OSWALD distributing leaflets on 8/16/63 in front of International Trade Mart, 124 Camp Street, New Orleans, was obtained on 12/3/63. New Orleans files reveal that on 11/25/63, six photographs taken of LEE HARVEY OSWALD and a person latter identified as CHARLES HALL STEELE, JR., were obtained from JOHANN RUSH, WDSU-TV, New Orleans. These photos depict OSWALD and STEELE passing out leaflets in front of the International Trade Mart on 8/16/63. Investigation did not uncover any film other than the TV film taken on 8/16/63 by WDSU-TV and WWL-TV, New Orleans.

These photographs were displayed to various individuals in an attempt to identify persons therein. Bureau is referred to report of SA DeBRUEYS dated 12/2/63 at Dallas, pages 687, 690-693. Bureau also refer to report of SA DeBRUEYS dated 12/8/63 at Dallas, pages 410, 412-420.
