Apr. 10, 1961, Smith: "The invasion is imminent. It could begin this afternoon...We are well equipped and well trained."

In last week of August, 1962, Cuban raid was staged by refugee student group, Alpha 66, in two small boats with 20mm cannons. Was Ferrie there?

10-23-62: Ernesto Rodriguez, director of the Spanish-language newspaper El Tiempo and head of a N.O. language school, said, "As an ex-Cuban citizen today I feel far better and prouder of my new American citizenship -- but I wish it had been done before."

Elliot Ross Buckley -- chairman of Citizens for a Free Cuba, met at 1209 St. Chas. in Oct. 62, called on U.S. to support all moves by Cuban exiles and others working to sabotage Cuban installations and other efforts to bring about Castro's fall.

Louis Rabel -- local head of Cuban Revolutionary Council, headquartered in Miami, largest of the anti-Castro groups. President in Sep. 62 is Dr. Jose Miro-Cardona. Rabel urges Cubans to join U.S. Army.

Sep. 15, 1962 -- More than 50 Cuban refugees filed into Customs House to ~~join~~ join U.S. Army...Report, from Washington say that Army is now preparing to accept Cuban refugees for guerrilla training.

Ruberto Pena, 117 Decatur, signed up for draft.

Oct. 23 -- Cuban training started at Fort Knox, no mention of guerrilla tactics.

Cuban exiles expressed hope today that Hurricane Flora would blow Fidel Castro off their island. Some believe she might. They said the hurricane may accomplish what anti-castro saboteurs had been risking their lives to do--ruin Castro's principal crops and thus devastate her economy. Some urged action.

"Now is the time to strike because electric facilities will be out for a good time, bridges are out, rails are washed out, and the only communication in Eastern Cuba is by radio," said the Rev. Germinal Rivas, of JURE"

Miami-AP A new all-out drive to unify Cuban refugees into a single, powerful organization to topple the Fidel Castro regime was disclosed today by exile sources. The plan calls for formation of a junta in exile to mount a three-pronged thrust consisting of sabotage, infiltration and ultimate invasion. The exile sources said the plan had been discussed with Cuban leaders by U.S. Central Intelligence agents. Seeking to put together the junta was Enrique Ruiz Williams, a Bay of Pigs invasion veteran and friend of U.S. ATTY. Gen. Robert F. Kennedy. Cuban leaders said intensive sabotage and guerrilla activities inside Cuba may start in a month to spark a possible uprising...

Hundreds of exiles, reported itching for action and resentful of U.S.-imposed curbs against anti-Castro raids will be recruited to infiltrate Cuba, the sources added."

Aug. 24, 1962, 11:30 p. m. shelling of Havana by the Cuban Student Directorate and other refugee groups. It was announced not as a harbinger of an invasion but as a show of force and unity of Cuban underground groups, said ~~px~~ Bringuier.

Citizens for a free Cuba formed here Spet. 25, 1962, the organization said it will urge stronger U.S. action in connection with the Cuban situation and implementation of the Monroe Doctrine. Cuthbert Brady, named vice-chairman; Ross Buckley chairman; Arnesto J. Rodriguez.

About the same time, exiles being urged to sign up for U.S. military register for draft.

Nov. 4, 1961--on occasion of visiting graves ~~px~~ here of bay of pigs who made it back to New Orleans ~~and~~ dead. Arcacha: We will never forget them. We hope that the people of New Orleans and of the United States will not forget that the Communist country of Cuba is so near.

"One day we will accomplish what they were never able to freedom and democracy for Cuba." The Bay of Pigs was just a battle lost. In the near future we expect to be fighting again... until Castro will be thrown out of Cuba." With him was Carlos Quiroga.
