This LHM is classified confidential in order to protect the identity of informants, the disclosure of whose identity could adversely affect the security of the United States.

Dissemination of this LHM is being left to the discretion of receiving offices. No local dissemination being made at Memphis inasmuch as Secret Service, USA's, Military Intelligence, and Alcohol, Tobacco and Firearms Division, Memphis, are kept informed of Invader activities by dissemination of LHM's regarding the Invaders.

LOWE regarding persons meeting with the Memphis Invaders at East St. Louis, Ill., on 5/16-17/70, but this source has been unable to furnish any additional pertinent background or descriptive data regarding these Unsubs.

This source is available to review photographs that receiving offices may believe to be individuals who met with the Memphis Invaders at East St. Louis, Ill., 5/16-17/70.
