Because you say you can scan onto a diskette instead of making copies of the one copy I have <sup>of</sup> to what was completed I'm sending you the second diskette. I take it that when you say "file" that is computerese and it refers to chapters.

That Times Mailer/Picasso interview is fine! He says what I've been saying and I'll probably insert excerpts from it. Thanks!

The Globe story on the allegedly nonexistent tapes is the official mythology and it is false. I've written ARRB and told them of tapes that must exist and that destroying any after the assassination was prohibited and why. Acknowledgement of that delayed letter also in today's mail.


I am sorry that I do not have time to write a real letter right now, but I did want to let you know that we did receive both the disk and the hard copy of the book. It is probably a good idea to send such items to my campus address, since our mail at home can sit in the box outside for some time before we retrieve it. It makes no difference on diskettes, whether it is an original or a copy; they are identical as long as all of the files on the original disk were copied to the new disk. I will also keep a copy of the original for back up, and will make a back up of changed and new files as well. One cannot be too careful with computer files.

I have checked the disk, and it seems to contain all of the files indicated on the label. Also, although it was entered using the Microsoft Word program, my word processor (Word Perfect) is able to read the files without any difficulty. I want to check all of the files to see that they are all complete and intact. I will do that soon and let you know.
