ABOUT ONE WEEK AGO WE TOLD YOU THAT A LOS ANGELES MAN WAS IN POSSESSION OF AN INTERVIEW WITH AN ALLEDGED SECOND JOHN KENNEDY ASSASSIN. WE CAN NOW TELL YOU THAT THE INTERVIEWER IS HUGH MACDONALD, CHIEF OF SECURITY AT HOLLYWOOD PARK RACETRACK.
