Saul, according to McDonald, then weaved a tale of being hired by unidentified interests for \$50,000 to shoot Kennedy, and that on Nov. 22, 1963, while Oswald was firing away from the depository, he fired a rifle fitted with a silencer from the second floor of the other building.

"I wasn't completely satisfied with Saul's story and when I came back (to the U.S.) so I did a lot of checking, McDonald said. He said the checking consisted mostly of comparing the alleged assassin's story against the report of the Warren Commission. According to 1963 city directory listings, the second floor of the Annex building was occupied on the west side (the side facing the presidential motorcade) by judge's chambers and clerks' offices: Workers in those offices told The Times Herald the windows in question were filled with employes watching the President's motorcade. A large tree in Dealey Plaza obstructs the view from the windows to where the President was hit.

Those trees were about half their present size on Nov. 22, 1963. McDonald said he never checked out whether. Kennedy could have been shot from that floor, or whether it could have been in any way plausible.

"I have never seen that building," McDonald said. "I've never been up there, I don't know whether it (the scenario of his book) is plausible."

McDonald's book states Saul was an assassin used at times by the Central Intelligence 'Agency' (CIA) and had participated in the abortive Bay of Pigsinvasion of Cuba in 1961. He claims a photo of ''an unidentified man' included in Warren Commission exhibits is actually Saul

He added he felt an "element" of the CIA was actually behind the assassingtion.

"One of the proofs of Saul's story, to me, is that it's not perfect, it's not pat," McDonald said. "It's got a lot of holes in it."
