At the reak of sounding like I'm bragging, it did not take me a year to do the first of the Whitewash series. I had a publishing contract that the publisher broke while drooling in the till and under that contract the ms had to be delivered by 2/15/65. It was. That gave me about 3/1 months to analyze the Report and skim the 26 volumes. The writing took about a month. To anywer your question how, long hours and accurate analysis combined is with a sensitivity toward evasions, nonsequiturs and other such devices. My background helped.

You've made a big mistake not to write Hood and I encourage you do do so immediately because they have a current and serious problem that might be relieved by providing some help to you.

There is a right-wing, sexist nut in the Baltimore area who has dedicated himself to making rouble for area women's colleges. First he went after an old and fine one near Baltimore, Goucher, alleging to the Beagan administration violation of Title 9 under which there is federal help. Now he's done the same thing with Hood, based on a note in the catalogue that on-campus quarters are not available for men. Instead of going to court, President Martha Church is trying to work things out without publicity. This means they have to find some way of accomodating men, may have done so and probably would welcome an opportunity to show that they do help men with accomodations in some way. So, I suggest that you write her, telling her that you are a doctoral candidate at Penn State, have had access to an archive of original records about 10 minutes from her campus, would like to spend the week of October 22 working in these materials, and does she have any accomodations on campus or does the college know of any availabilities consistent with students' financial limitations.

You don't know what I've told you. See how she responds and if she doesn't help then I'll call around. Probably one of the older tourist camp types have lower rates. The chain motels charge the chain prices.

It may be that your letter will reach the friend on the faculty who cued me in as above.

When you are going over the Commission file you can, without extra effort, do a favor for a history professor who is doing a book on J. Edgar Hoover. I had made a file of duplicates relating to his Commission testimony, it has disappeared and this professor wants copies. If you'll just flag them as you go through the file we'll make the copies and send them to him.

Before I forget, now that you've read IV and the comparison between the actual and the Ford transcripts of 1/27, you ought also get Ford's sworn confirmation testigony that he did not take anything for profit and nothing classified. I have that published hearing, probably in the basement.

The weather has changed and in a couple of weeks the basament may be rather cool so I suggest you come propared.
