Re San Antonio airtel to Bureau dated 9/28/64 with an enclosure to the Dallas Office of a notebook of the Sheraton Hotel which was found by [redacted] San Antonio, Texas, in Room 2422 of the Sheraton-Dallas Hotel, Dallas, Texas, during his stay at this hotel from September 24 through September 27, 1964.

From a review of the contents of the notebook, it would appear that the unknown writer of same was interested in instant investigation as it pertains to the association between LEE HARVEY OSWALD and GEORGE DEMOCHRENSCHILDT. The "GDM" mentioned frequently in the notes is most likely the latter individual.

It is noted that the name of SAMUEL B. BALLEW appears in this notebook. BALLEW was interviewed on October 5, 1964, regarding the identity of anyone he had discussed OSWALD or DEMOCHRENSCHILDT with during September, 1964, who was staying at the Sheraton-Dallas Hotel. BALLEW stated that he had had several detailed discussions regarding

DEMOHRENSCHILDT with GEORGE McMILLAN, an employee of the National Broadcasting Company, who was in Dallas for several weeks during September and who stayed at the Sheraton-Dallas Hotel. BALLEW stated that McMILLAN was assigned by NBC to prepare a television program based upon the background to the assassination of President KENNEDY, which program was to be aired upon the release of the report of the findings of the President's Commission.

BALLEW stated that he had not contacted anyone else at the Sheraton-Dallas Hotel in this regard during September, 1964.

No record of GEORGE McMILLAN having occupied a room on the 24th floor of the Sheraton-Dallas Hotel during September, 1964, was located; however, it was determined that one GEORGE McMILLAN, Box 299, Aiken, South Carolina, was a resident of this hotel from August 30, 1964, to September 17, 1964. A copy of this person's hotel registration card (#Z-87949) was furnished by BARNEY TOBIN, Reservation Manager, Sheraton-Dallas Hotel.

There are being forwarded to the Bureau the following two items, which are enclosed herewith:

1. Notebook of the Sheraton Hotels and Motor Inns consisting of six pages with a cover identified by ELMER E. COOPER, MD, Room 2422.

2. Copy of Sheraton-Dallas Hotel registration card #Z-87949, of GEORGE McMILLAN, Box 299, Aiken, South Carolina, for Room 2521.

The FBI Laboratory is requested to determine if the writer of the notebook is possibly identical with one GEORGE McMILLAN, former guest of Room 2521 at the Sheraton-Dallas Hotel.

Upon completion of the aforementioned examination, the Bureau is requested to advise the Dallas Office as to the desired disposition to be made of this notebook and whether it desires the interview of GEORGE McMILLAN concerning the contents of this book.

Interviews conducted by the Dallas Division in this matter will be set forth in the next Dallas report submitted after the report of 10/8/64.
