The FBI LHM on Gene Crawford with your 6/18 is one of a series of records relating to him disclosed to me in the King FOIA case. Now you have Wayne Chastain's sausage and eggs man. Wayne had been a good friend when he was on the paper and I'd tried to ease him off the obvious irrelevance out of which he sought to build a book and a solution, but to no avail. He was so upset after ¹ told him what the records show I've not heard from him since.

I don't recall having noticed any notation of the use of stencils but I presume reference is to a mimeograph stencil and the notation is merely not to preserve it because there was no probability of any need for additional copies. In those days I'm ceftain that where a number of copies were needed mimeo was much cheaper. So, I think that copies of the N FD 302 of the Crawford interview were made with the stencil, after which it was disposed of rather than cluttering a file without need.

Only news relates to JFK field offices case in which sanctions had been assessed against both Jim and me, with dj/FBI claiming almost \$10,000. On remand, fink district court judge dismissed sancyions against Jim and reduced those to me to close to \$900m which I've told my ACLU lawyer I'm not paying. He is scared. He backed off of an earlier agreement to reopen the whole thing with new evidence, disclosed to "ark Allen after the record in my case was closed. This new evidence, properly handled, is enough to get the whole thing thrown out with onlymm mimimal honesty by the courts and is actually enough, in other than this Reaganite era, to justify perjury charges against the FBI's case agent in this litigation. Who happens also to have the same role in "ark Allen's case and thus can hardly claim ignorance when he swore so falsely to the most material things.

To make this compehensible, he swore in my case that certain relevant material did not exist and he disclosed it in ^Mark's case. In my case they also swore that discovery from me was necessary so they could prove that they had complied with my request and what they disclosed to ^Mark establishes not only that this is impossible but that they knew it all the while - and never corrected any representation to any court.

I bope I do not wind up having to be my own lawyer. Meanwhile, I'd addressed the ACLU fellow with some pointedness about fear and its consequences. When we spoke last week he said he'd give it more thought and I'm awaiting word. Jim can't handle this because of the continuing possible conflict of interest and if this were not true he'd also be afraid. Real-life soap opera!
