Dear Bill,

Waiting for the new computer is fine as is doing whatever may be necessary with the copy of O in NO. Probably another few are around somewhere. We lost track of much when a professional cleaning crew cleaned up after a furnace blowback. They could not begin to put things where they had been. As you had a chance to see!

On the second Whitewash master you say you'll send, will you please seal that in a box and label it? That way it will be identifiable and someone can take it to the basement for me. I'm beginning to get short on shelf space for what I'm putting in boxes. For that reason I'll be giving that fine album of pictures to Hood-space. Meaning, that I can get to.

Do not take any more time on the manuscript of Case Open, originally titled Hoax. I should have written you as I did write Hal, they they did not retype all of it on that diskette or the entire diskette was not printed out. I have the original ms., the rough draft, and a printout they gave me of close to 800 pages. There is also a duplicate of these pages at Hood.

It is fine of Charles to be thinking of taking the time required to get O in NO to a 6x9 size. Please let him know we do appreciate all he is doing.

Please tell the girls to use a highlighter on the rough draft when they come to what they do not make sense out of. Note that I did not say if they do. With the rush of my work it is inevitable. And it will be very helpful when I read it if they place on the rough draft where a page as retyped begins or ends. If I have to check the rough draft that saves me much time. *ask them to use a color, not black, catches eye faster*

On that, I quote a book by a former CIA photo interpreter, approved for publication by the CIA, that I had only a chapter or two of. I was just told that it is being remaindered by Baker & Taylor. It is Eyeball to Eyeball, by a man name Buriggioni. If you are interested in the fact that Oswald had no secrets for the KGB and why it had no interest in him, that part of that book makes it clear.
