Dear Mr. Weberman:

You appealed from the action of the Federal Bureau of Investigation on your request for access to records pertaining to Charles "Datz" Murret.

As a result of discussions between Bureau personnel and members of my staff, a supplemental release of six pages is enclosed. After careful consideration of your appeal, I have otherwise decided to affirm the action in this case. Mr. Murret is not the subject of a Bureau main file, but is alluded to briefly in several files pertaining to the Kennedy assassination. The Bureau processed only the portions of those files which pertain to him. Certain information was properly withheld from you pursuant to 5 U.S.C. 552(b)(7)(C), which pertains to investigatory records compiled for law enforcement purposes, the release of which would constitute an unwarranted invasion of the personal privacy of third parties, in some instances by revealing an investigative interest in them on the part of the F.B.I. This information cannot be the subject of a discretionary release.

For your information, material withheld by the Bureau pursuant to 5 U.S.C. 552(b)(1) contains no mention of Mr. Murret and in no way pertains to him.

Judicial review of my action on this appeal is available to you in the United States District Court for the judicial district in which you reside or have your principal place of business, or in the District of Columbia, which is also where the records you seek are located.
