Recently, I did a little research for you concerning the Index of the Warren Report. A few things which I list below may warrant looking into.

The "O's" and "P's" are missing. I was wondering if these pages could have ~~been~~ been torn out. ~~When~~ I tried to determine what type of book this was, but the closest identification I can find is in Vol 14, page 289. Bert Griffin admitted on this page that he could not know how it was bound.

2. Volume 22, page 196, CE 1156, Mrs. Marina Oswald is asked about Mrs. Paine's notation on her calendar such as "Oct 23 - LHO purchase of rifle." Marina is quoted as saying, "She said she does not know what this notation means — etc." When I checked Mrs. Paine's calendar CE 401, Vol 17, page 59 I noticed that only an "X" is visible for Oct. 23.

3. Volume 22, page 332, CE 1222, Mrs

Coffman is ~~not~~ quoted as saying Ruby knew officer Tippit because of his numerous visits to Ruby's club. Is this possible because I never noticed that Tippit's duty included the downtown section and because Tippit I believe went on the force in either 1952 or 1953.

4. Volume 24, page 280, CE 2003, Lee Oswald wrote that he was responsible for the New Orleans City Attorney General putting a restraining order on the Cuban <sup>STUDENT</sup> Directorate from selling some so-called invasion bonds. Has this ever been checked out?

5. Volume 26, page 94, CE 2718, the Retail Merchants Credit Association of Fort Worth stated they had no record of the Oswalds. However Lee did purchase a TV set at Montgomery-Ward in 1962 + returned the set a few weeks later. Would not that be listed?

6. Volume 26, pages 602 + 603, CE 3050, does that photograph appear anywhere. Mr Foster said he ~~was~~ made a copy of it available to interviewing agents.

I hope these questions are not duplicating any of your work. No reply is necessary, but I hope they may aid you.
