## Projected Shaw Hearing Date Is Set by Haggerty

Expects Preliminaries to Be Over by Sept. 18

The first indication of when the hearings on defense quash motions preliminary to the conspiracy trial of Clay L. Shaw would end was given by Criminal District Court Judge Edward A. Haggerty Jr. Wednesday.

The projected date, by which Haggerty said he expected all the preliminary proceedings disposed of, was set at Sept. 18, despite defense objections that testimony may not be over by that time.

A hearing earlier this summer on the original defense quash motion fizzled out due to a large amount of legal technicalities. At that time Haggerty ordered the defense to file an amended motion to quash.

Shaw's conspiracy trial is expected to begin in late September or early October.

Judge Haggerty said he thought testimony would be completed by Sept. 18, adding, "Everybody wants a speedy trial.

"We also want a speedy trial," Dymond said, "but we don't want to waive any of the defendant's rights."

He added that the defense intends to file all the motions it thinks necessary.

Earlier during the hearing Judge Haggerty ruled that the state's answer to a defense query was sufficient.
