During our conversation at New York in August 1969, you asked me whether or not Mr. Thomas C. Lucey's account (Pages 12, 13 and 14, THE OVERSEAS FAMILY, June 20, 1969) was substantially true, and, if you recall, I replied that I would rather not answer that question "at this time."

Now, however, for reasons that are partially predicated on the death of Senator Richard B. Russell yesterday, I feel obliged to answer your question. I am doing so by enclosing herewith a copy of my own account, written and printed about one year ago, which, I believe, you will find a satisfactory answer.

I have also enclosed a copy of Senator Russell's reply to a letter I wrote him from Leavenworth in January 1967 immediately upon being apprised of Mr. Jack Ruby's demise in Dallas. My somewhat lengthy letter to Senator Russell (who was then head of the so-called CIA Watchdog Committee) detailed the CIA's involvement in President Kennedy's assassination, as far as it concerned several others and myself, and, I might add, it was written almost two months before Mr. Jim Garrison's investigation into the affair was made public.

WASHINGTON, Jan. 18.-Sen. Richard B. Russell, who was a member of the Warren Commission which investigated the assassingtion of President John F. Kennedy, says he never believed that Lee Harvey Oswaid planned the assassingtion gione.

"I think someone else worked with him (or the planning)," the Georgia Demcrat said in one of a serieof taped television interviews. to be breadcast next month by WSB-TV, an Atlanta television station. "There were too many things—the fact that he (Oswald) was at Minsk (in the Soviet Unior.), and that was the principal center for educating Cuban students some of the trips he mode to Mexico City and a number of discrepancies in the evidence, or as to his means of transportation, the luggage he had and whether or not anyone was with him—(that) esticed me to could that he planned it all booth weil," he

Dear Mr. Nagell:

This is to acknowledge receipt of your letter of November 21, 1968 concerning the return to you of certain items that were used in evidence against you at your trial. I have withdrawn from evidence the 45 caliber revolver and the set of handcuffs with key, and I have them in my possession. As to the other items which you mention in your letter, according to my secretary, and to the best of my recollection, these and a number of other items were sent to your sister Mrs. Gambert sometime back.

On November 27, 1968 to wrote to Mr. John F. Malone, Special Agent in Charge, FBI, 201 E. 69th Street, New York, N.Y. inquiring if he would receive the gun as you requested. To this date I have received no reply from him. Therefore, I thought it best not to send him the gun as you requested, unless he was disposed to receive it. If you want me to send this gun to its proper owner, please send me his name and address so that I may write to him asking if he is willing to receive it. Then, please send me \$5.00 to cover the mailing charges for the gun, and the handcuffs which I assume you want. Under the mailing laws, as I understand it, I must get a registered gun dealer to mail the gun for me; individuals are not permitted to send guns through the mails. If there is anything left over from the \$5.00 I will send it back to you; if there is anything owing above \$5.00 I will bill you for the difference.

I trust this letter finds you in good health. I wish you a Merry Christmas and a Happy New Year.
