Information was received from the American
Consulate General, Zurich, Switzerland, that one RICHARD CASE
NAGELL had come to the Consulate General on June 4, 1968 and
stated that he had been interviewed by New Orleans District
Attorney JAMES C. GARRISON in connection with the latter's
investigation of the assassination of President KENNEDY. He
had been told by GARRISON that his life was in danger.

NAGELL furnished the information that he
was born on August 5, 1930 at New York City and held U. S.
passport J 543069.

1. [redacted] CAME TO CONGEN JUNE 4, TOLD COHERENT
STORY ABOUT "WORKING FOR SECRET US GOVERNMENT AGENCY ONI MISSION
TO GENEVA WHERE TO MEET JAPANESE". WANTED CONGEN ASSISTANCE TO
GET MONEY WHICH CLAIMS HAD DEPOSITED NEW YORK BANK BEFORE
DEPARTURE US. [redacted] WAS TOLD CONGEN COULD NOT ASSIST.

2. [redacted] RETURNED TO CONGEN JUNE 5, WAS SERIOUSLY INCOHERENT
THIS OCCASION, APPEARED PSYCHOTIC, POSSIBLY DANGEROUS. [redacted]
CLAIMS WAS INTERVIEWED BY NEW ORLEANS DISTRICT ATTORNEY
GARRISON MAY 14-16 IN CONNECTION "CIA AND PRESIDENT KENNEDY
ASSASSINATION". [redacted] CLAIMS GARRISON TOLD HIM HE IN DANGER
BEING KILLED THEREFORE WANTS "INFORM CIA HE IN ZURICH". [redacted] ALSO
SAID "US GOVERNMENT HAD PREVIOUSLY WITHHELD PASSPORT FROM HIM".

[redacted] DID NOT SEEM KNOW OF SENATOR KENNEDY SHOOTING, HENCE
HIS CONDUCT APPARENTLY NOT PROVOKED BY THIS.

3. DEPT REQUESTED PROVIDE TELEGRAPHICALLY ANY BACKGROUND INFO
AVAILABLE ON [redacted] AND ADVISE WHETHER CONGEN SHOULD INFORM
POLICE OR TAKE OTHER ACTION. TRIVERS
