Information was received from the American Consulate General, Zurich, Switzerland, that one RICHARD CASE NAGELL had come to the Consulate General on June 4, 1968 and stated that he had been interviewed by New Orleans District Attorney JAMES C. GARRISON in connection with the latter's investigation of the assassination of President KENNEDY. He had been told by GARRISON that his life was in danger.

NAGELL furnished the information that he was born on August 5, 1930 at New York City and held U. S. passport J 543069.
