Dear Mr. Weisberg:

This is in reply to your letter of October 11, 1967 concerning records of the Warren Commission.

The statements made in our letter of October 9 to you were correct. The original papers we received from the Secret Service do not include any papers that are not shown in Commission Exhibit 397 (XVII, Hearings, pp. 29-48) and CE 387 (XVI, Hearings, pp. 978-983). They do not include any autopsy notes not shown in CE 397 nor do they include an authorization for the autopsy.

Copies of these original papers were furnished to you on October 10. The copy of CE 387 which we furnished to you was made from the original of the typed autopsy report turned over to us by the Secret Service, not from a Xerox copy. You may compare the original papers with the copies furnished to you and with the published exhibits. If you will point out any pages which you did not receive, we shall be pleased to duplicate them for you.

Enclosed is a copy of a portion of CE 3120 which you requested.
