Dear Mr. Weisberg:

This is in reply to your letters of October 26 and 27, 1967, concerning records of the Warren Commission.

The three memoranda to which you refer are consistent with the conclusions of the Commission and are properly withheld from research.

The only communication dated July 22, 1964, from Norman Redlich to Wesley J. Liebeler in the records of the Commission is the letter of that date to Mr. Liebeler in Dallas, a copy of which has been supplied to you. There are no memoranda from Mr. Redlich to Mr. Liebeler with that date. The letter of that date makes suggestions for the questioning of Deputy Sheriff Walthers and Buell Wesley Frazier in Dallas. As you will note, there is a reference to Walthers and Cuban sympathizers in the letter, but none to General Walker and Cubans.

A travel voucher in the records of the Commission indicates that Mr. Liebeler 1987 Washington on July 20, 1964; that he was in Dallas from July 21 to July 24; and that he returned to Washington on July 28, 1964, after further travel. If Mr. Redlich had any information to convey to Mr. Liebeler on July 22, 1964, concerning "General Walker and Cubans" or other subjects, it seems logical that he would have included it in his letter of that date to Mr. Liebeler. Any information concerning "General Walker and Cubans" would presumably have had a connection with Mr. Liebeler's work for the Commission in Dallas, including the questioning of General Walker. If Mr. Redlich had prepared separate memoranda, the natural procedure would have been to enclose copies of them with his letter to Mr. Liebeler, in order to transmit the information to him as soon as possible. As you will note, there is no mention of enclosures in the letter.
