In today's mail, with no return address or inside message, I received the enclosed new (June 10) Archives internal memo on the designation of Steven Tilley to serve as liaison with other agencies and the presidential libraries on the disclosure of JFK assassination records.

I do not recognize the handwriting on the envelope.

Nobody I know would address the envelope as it is addressed.

I therefore believe that this was sent anonymously by an Archives employee who had heard of me and my work or saw records relating to me. Belief it is the latter is the zip code, canceled at least a year ago.

Mr. Tilley will serve as the NARA agency liaison with the Kennedy Assassination Records Advisory Board. His duties include providing advice to all components of NARA as well as other federal agencies, overseeing the review of records under the provisions of the statute, and consulting with Congressional staff, White House officials, and others on issues and questions relating to the establishment of the collection.

Mr. Tilley will serve as NARA's contact point for all inquiries concerning the JFK collection. He will provide guidance on issues for all NARA components, including the Presidential Libraries, that hold assassination records covered by the statute. He will be traveling to those Libraries in the near future to provide guidance to the staff. He will also be working closely with the JFK Task Force in NS on the review of the records of the House Select Committee on Assassinations and other related Legislative records. He will also be coordinating a second review of assassination records.

As the deadline for the opening of the JFK collection approaches, there will be increasing interest in this matter from the press, the Congress, and the public in general. It is vitally important that NARA have a consistent, coordinated policy in regard to the establishment and maintenance of the JFK collection. The liaison position was created to fulfill this purpose, and I am sure Mr. Tilley will have the cooperation of all NARA components.


