Tippit (see entry 9); (2) Other Individuals and Organizations Involved or Interviewed (see entry 10); (3) Subjects, including (a) Governmental Agencies Involved (GA; see entry 11), (b) Investigation and Evidence (INV; see entry 12), (c) Maps, Photos and Press Clippings, Films, Tape Recordings (MP; see entries 13-19; orly a few items involving maps have been found in this series), (d) Presidential Commission (PC; see entries 20 and 21), (e) Protection of the President (PP; see entry 22), and Public Comments and Inquiries (PUB; see entries 23 and 24); and (4) Reports and Source Materials (REP; see entries 8, 27-32, and 34). The files have been rearranged to some extent by the National Archives. A "relative index" to the manual serves as a guide to particular subjects in the files. For the detailed file classification scheme and the relative index, see appendixes I and II.

Also included are such items as "Welcome Mr. Kennedy to Dallas," the title of an advertisement appearing in the Dallas Times Herald on November 22, 1963. Entries show name or subject involved, control number of Secret Service report (see entry 8) in which the name or subject is mentioned, and the file number for the investigation (CO-2-34,030).
