362c O's autopsy reprot. It contains copy 2 of the Kennedy autopsy, which in turn contains an extra sheet authorizing the postnortem, by Mrs. K, witness RObt K. Page 3 of this copy, which is partly indistinct, contains at the end of the girst line of the second par." 7/2'5" "; the next line, (probably) "4/25" " and under the fourth line, between "Right" and "mastoid" is a written slash, under which something is written in by hand, croassed out presty effectively, and then the number, in quotes "5.6" is written. None of these numbers appear in the original. Also stapled to this version of the autopsy is O's postal form for the POBox, applied for 11/1/63, No. 6225. Missing from the file are the O charts, etc. sand pp 438-9 of Dallas police report

Doc 705, 4/2/64, JEH to Rakkin covering 3-page report on 0's room, which was 5x 13½, with four double-hung windows on north wall, each 32" wide and with one 32" window on 5-foot wife east wakk. Fourth par: "Mrs. JOHNSON advised the room is/essentailly the same condition as when occupied by LEE HAR VEY OSWALD with the exception of the new draphries." Next it quotes her as saying there had been window-coverings when 0 rented. The report is evasive.

Doc 774, pictures of bullets marked C251, C252 and C253, covered by letter of 3/27/64, JEH to Rankin. 251 badly mutilated, pieces missing; 252 less so, and 253 slightly so. Letter begins "The remaining three bullets from Officer J.D. Tippit's body were recently received from the Dallas Police Department..." But at the bottom of the second page this bullet is referred to as C13 "(the first bullet submitted by the Dallas Police Department in the Tippit case)". The end of this paragraph, referring to spectrographically companed cartridges, says they came from the revolver, from O's pockets "and the U.S. Secret Serwice."

Doc 371- contents: Bouck's # 11/26/63 receipt; Galloway of 25/11/63, neither of which bear the CE397 mark, the Humes telephone note, the 15 holograph aut. pp., the body chart, which does not bear the exhibit no. 111 the head chart, which does, the Humes receipt for his notes and draft and his burning certification.

FBI report, Exhibits, vol 1, shows sixth-floor window opem in Exhibit 29, with what may be box inside open one, high stack of boxes behind and to west of vertical divider, one or two men in window directly underneath, at a single window, not with men at the three ones windows on the floor below and a tall, indistinguishable gray object, like a pole, seeming almost to bisect the western of the pairs of windows vertically but it is in fron of them and the wall of the bldg, extending upward to the sixth-floow window and to the bottom of the picture. The caption reads "Enlarged print from 8mm movie film of window from which shots were fired. Picture was taken moments before assassination. Top floor (7th) not shown in this photograph". Interesting. Waht 8 mm movie? Is it in evidence? How about the rest of it?

Doc 298, visual aids, lists J.E. Hughes 8 mm movie, 17 seconds, motorcade turning into parkwa y; Zapruder, 33 seconds; Nix, 8 seconds. Brochure. No covering letter.
