

* 7/8/66 Doc 79 SS interviews with Marina, dated 11/29, 12/3,5,9,10,11/63 - no. 319-9pp.-all; First page of 536, report of 12/5, clearly indicates Oswald went to Irving, in Marina's opinion, to patch up the quarrel they had had over his use of the name Lee (previous report quotes Marina's opinion, also Lee's, that FBI prevented his employment) (didn't get copies); 416, also 12/3, which is CE1787. 536 is CE 1785. 319 is marked CD1792. In view of the closeness of the numbering, is it possible there is an error? 416 is less than 4 pp; 536 four unnumbered pp. 12/3/63, no. 322, also marked CD 1786, Memo on and translation of original of O's alleged note prior to attack on Walker; 7 pp., inc. Russian by Marina "of her interpretation of the letter" by O. Compare this with what the Com says is his note.. 12/9/63, Gopadze rpt, 3 pp, no. 554, CE 1790 . Interesting, if numbering accurate, that some used as ex, some not, and reason for each. 12/11/63 rpt, Gopadze, no 632, CE 1789. Check and see if this really is an exhibit, for if it isn't, it is interesting in that she says he never dry-practised with his rifle anywhere (p/2), that it was her idea she return to USSR, and explains how others got 35% hunk of her!

P37, re 1494, quotes Truly 9/11/64 as saying approx 55 lbs each, Getting p 42, Truly on access to 6th floor-all sorts people $\frac{1}{2}$ hr after ass. P48 quotes L t Day approx same effect, he assumed they were newsmen. P 51 Studebaker (9/9) says he got to TSBD 11/22 "very shortly before 2:00 p.m." Compare Rowland. Page 52 Stude: ".it was his personal opinion that there was very little restriction, if any, on people moving freely in and out of the TSBD on November 22,23, and 24, 1963" Getting pp. 66-8. Beginning with p/ 110 stuff on "F.O."m car, Bogard submitted to polygraph, results not given. Instead "The above series of questions (all resulting in identification of potential customer as O) do not include irrelevant or control-type questions, which are used during the polygraph technique. For the most part, these are questions of identity and do not relate to the substantive investigation." Whatm thwn, was the purpose of the polygraph? All q's answered against Commission theory, and no negative result on test! To p. 123, where there begins the story of Clifton M. Shasteen, 2214 Fairfax, Irving, Tex., who says someone looking like Oswald, also accompanied by 14 yr old boy and driving what he believed to have been Mrs. Paine's Stationwagon, was in his barbershop ~~for~~ several times before assassination. (Note, reference to pp. 635,6 of Gemberling's report of 12/23/63 indicates its size). Confirmation similar appearance by Barber Bert Elmo Glover, barber, who paced age at 34-5, to p. 131.
