when considered separately. Because  
of the involvement and possible  
arrogance of the Kennedy family  
and the Department of Justice if  
Weisberg approaches them for additional  
related material, I think it best  
to withhold our material, which is  
attached, in order to get a policy  
decision from the Department through  
its Freedom of Information Committee  
as to whether this material should  
be released. This can be done if  
Weisberg appeals the denial.

I have revised the draft to  
include Mr. Harfinske's suggested  
revisions.
