Door Cyril,

Prior to receiving your letter of the 19th I had filed your previous letter, not intending to respond. Periodically I tell syself I have to sethink my position. Regularly I tell syself the hell with it, I've ruined our lives and futures with the sork I've done and the only thing to do it get beneat-like, stop wasting time trying to help other who do little or nothing to contribute to what we know, forget about trying to prevent sistence and blunders, for I cannot, and just get done what I want to get done so that at some point we can begin to live like menschen again and perhaps my reputation will not be so destroyed that I can again make a living.

This lattimer trings is only one aspect of that I anticipated and wrote others about. You never responded, but perhaps a year ago I wrote you end told you I had figured out a sefe way to accomplish our purposes, that with I then had you and I working together were rinelly in a position to really do something. You never responded. In September or October I saw at least two possibilities for hurt to us, and I wrote various people, in each case trying to avoid imposing by jungument on them and anking them to think for themsives of the lazard that to so impended. Not one replied to say I have thought this through with care and I see nothing, so what do you have in mind. Perhaps some, as you, consider them solves too busy. As in another context are perhaps with too much emption I tried to make you understand, the difference in our (pl.) being busy is that I put in longer hours them I tuink next are capable of and an the only one who does it without in return getting the means of simplest sustainance. So, when I'm told others are busy, I have a special kind of reaction to it. You may recall that you adoed panhandling.

Beginning then I did start to reorder by life. I have and have had a book that could have come everything for us - could not being certainty - because of their stupidity in using lattimer. I could not bring it out. BUT, I am not going to give may of it away, regardless of cost, and if may of those to whom I have shown or losmed or given parts use any of it, I have remembed the point where I'll nee if I can protect my rights.

One of the consequences of boing busy, especially where money is involved, in that those so busy making the somey to not have time to think of other things. On the other hand, having resigned syself to not making money, I do have time to think, Many complaints have been made of me, and one of the reasons I acked a those to think about what I forecast is so that I would not have to face one of these accusations, trying to impose my views on others.
