We enclose copies of the following papers: (1) a letter of September 17, 1968, from Mr. Harold Weisberg, author of <u>Whitewash</u> and other books relating to the assassination of President Kennedy, threatening legal action against NARS; (2) a draft of our proposed reply to Mr. Weisberg; (3) our letter of September 13, 1968, to Mr. Weisberg and of previous correspondence with Mr. Weisberg about the same matter; (4) a letter from the Chief of the Secret Service of October 2, 1967, and two receipts relating to the transmittal of the original autopsy papers, referred to in the Weisberg correspondence, to the National Archives; and (5) a copy of the testimony of Dr. J. J. Humes in the <u>Hearings</u> of the Warren Commission (Vol. II, p. 372-373, particularly the marked portion) on which Mr. Weisberg bases his claim that there are original notes relating to the autopsy of President Kennedy that have not been transmitted to the National Archives.

We would appreciate your advice as to whether our proposed reply to Mr. Weisberg is correct from a legal point of view.
