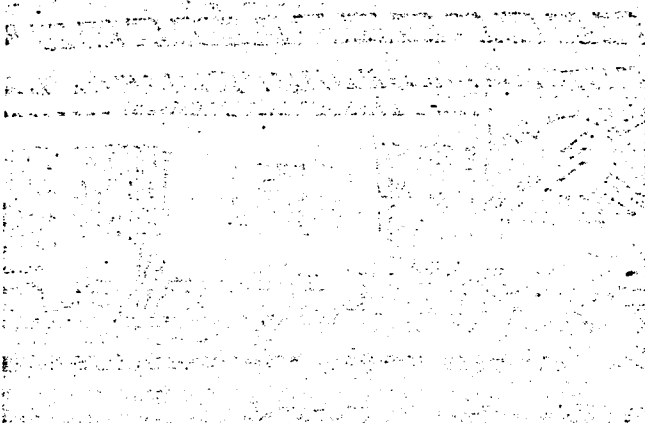
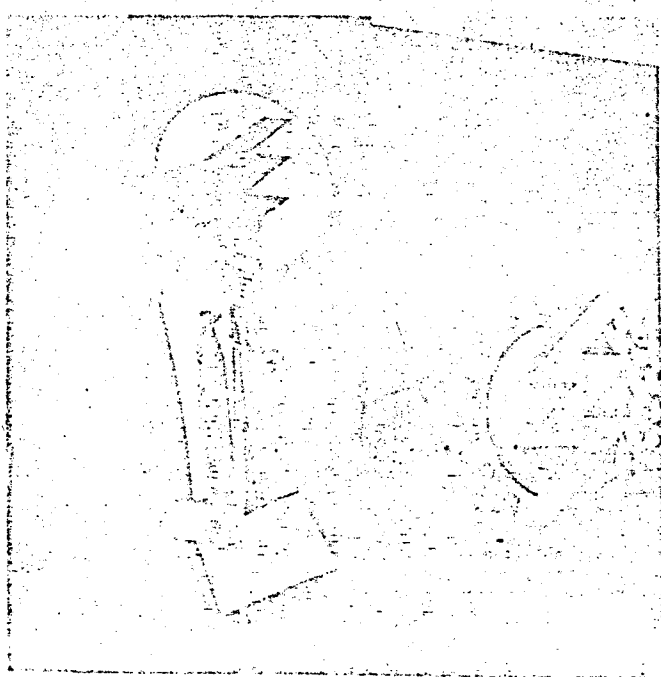

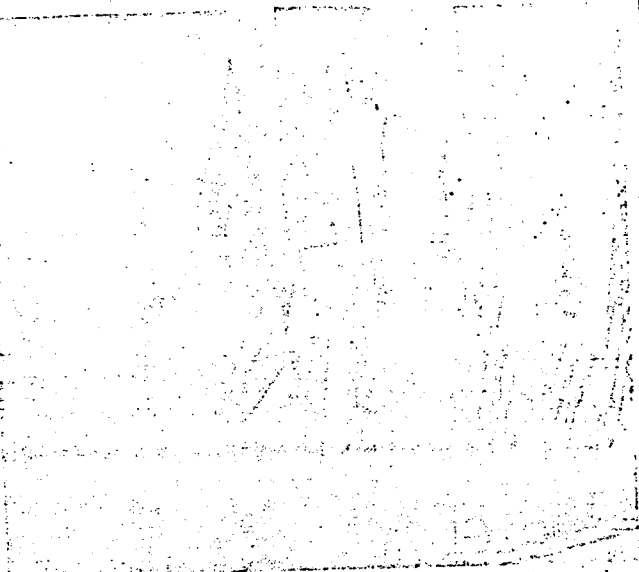
OHIO NEWS

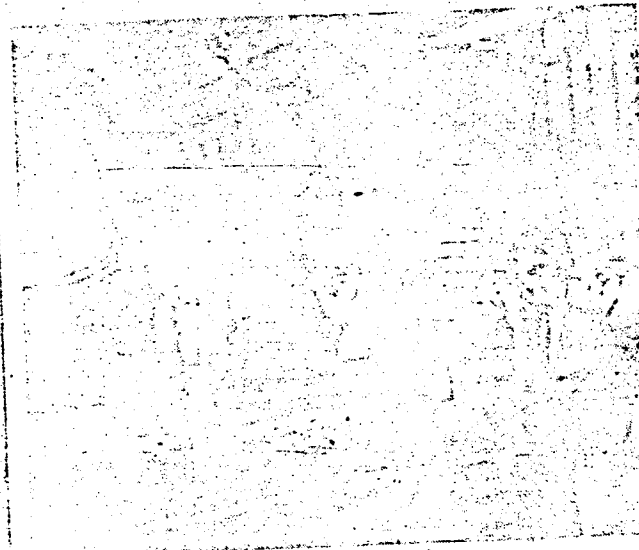

J. B. STONER ANNOUNCES 1971 SPEAKING MASS MEETING CAMPAIGN

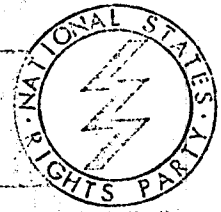
We make this announcement early because it will take much planning for vacations, chartering of buses by Chapters, etc. This will be the

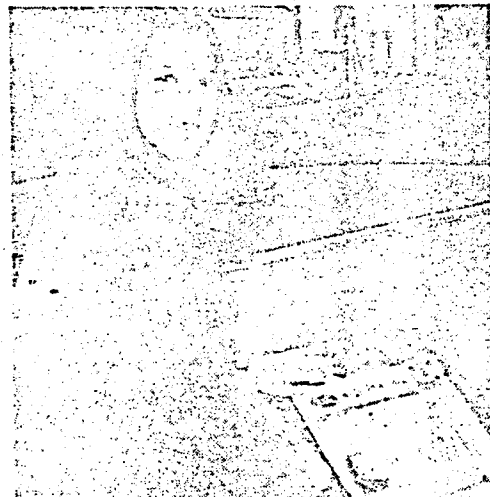

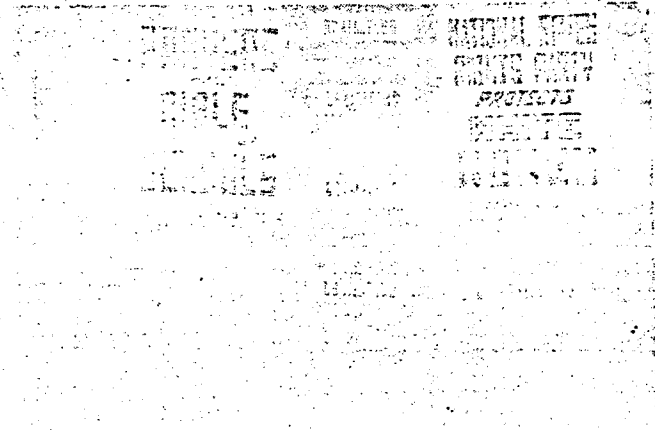

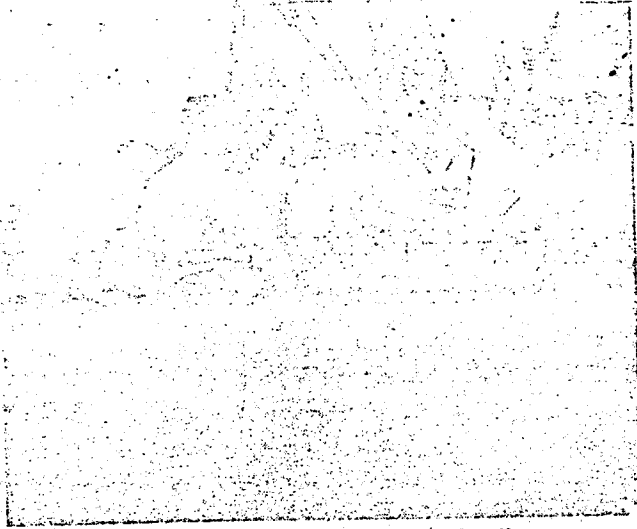
BILL BRAILSFORD'S SHERIFF'S RACE

Jerry Heinemann was in charge of the march and all members want to thank him for his fine job in leading another successful parade.

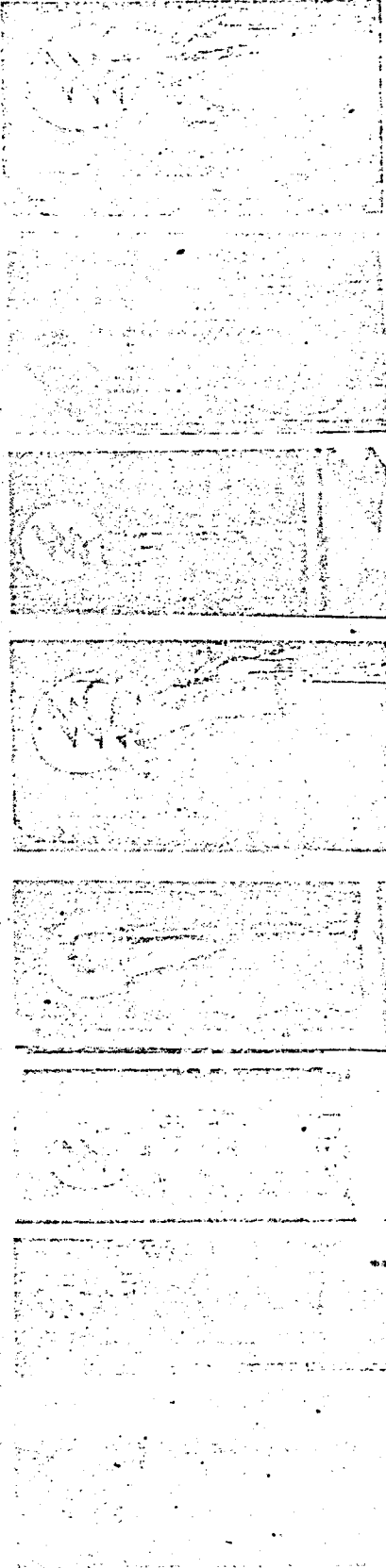

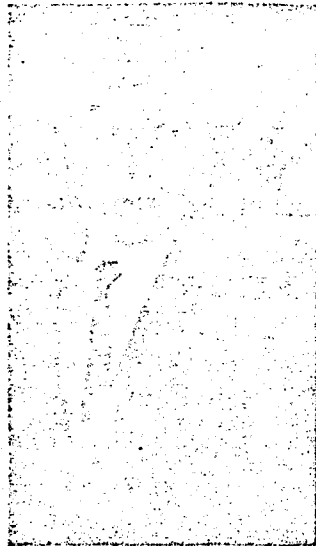

N.S.R.P. in Washington Victory March

The Second MARCH FOR VICTORY, lead by Dr. Carl McIntire, in Washington, D. C., Sat., Oct. 3rd, was a complete success for all those who participated inspite of the outright lies of the Jew-controlled newsmedia. Attempts were made to stop the March from the very beginning. Jew Henry Kissinger, head of the Nixon regime, went especially to Paris to stop Vice President Ky of South Viet Nam from addressing the Victory Rally. The newsmedia then spread rumors that a massive hippy counter-demonstration would take place in order to frighten patriots away. Finally after the Rally's great success, the newsmedia told outright lies regarding the size and magnitude of this historic occasion. Washington, D. C. officials on the scene estimated the crowd as twice that of the first March last April 4th, ranging well above the 140,000 mark. And the result of tremendous political pressures, only Louisiana Congressman, John Rarick, had the courage to come and address the Rally.

Units of the N.S.R.P. again participated in a record number coming from N. J., Penn., N. Y., Maryland, Georgia, and the largest from Virginia. There was no organized effort made this time to march in one giant formation as was done on April 4th, but amazingly enough many N.S.R.P. units found one another to make a very impressive showing throughout the three hour parade down Pennsylvania Ave. to the Washington Monument grounds for the Victory Rally. The main N.S.R.P. Flag formation was requested by Georgia participants to head their contingent of more than 500 persons behind which a hundred N.S.R.P. uniformed Virginians marched. There was a slight misunderstanding regarding our right to carry the THUNDERBOLT Flag on the part of some parade marshals. It seems that certain elements of the John Birch Society had been suspicious of the N.S.R.P. and had requested that the area was quickly cleared up by the Grand Marshal who apologized for the misunderstanding. A meeting is being scheduled between several key staff personnel and N. J. - N.S.R.P. members to once and for all

expose the divisive nature of the J.B.S. and its vicious smear campaign against the legitimate Right Wing. It is interesting to note that the J.B.S. flatly opposed support for the Victory March and even worked against it, which ought to prove once and for all that the John Birch Society is nothing more than a C.I.A. front to neutralize and betray effective anti-communist activity.

A climax was reached two-thirds of the way through the Rally as two Viet Cong flags were captured from a Jewish lead mob by gallant 'Hard Hats' from the skilled trades unions. As a result the hippy vermin (about 3000 strong) turned and charged the N.S.R.P. Color unit standing on a rise below the Washington Monument. Surrounding Rally participants fled as the anarchists drew near the N.S.R.P. Flags leaving the seven Men of the THUNDERBOLT alone. The N.S.R.P. Flag unit refused to yield an inch of ground and braced for the initial contact when all of a sudden within 30 feet of the approaching radicals hundreds of young White men rushed down from behind the N.S.R.P. Flags and smashed into the ranks of the Jew-anarchists. The fighting was fierce until the Washington, D. C. police came in droves to tear the two groups apart. The result was that the third and final Viet Cong flag was captured along with several American flags the hippies were carrying upside down. One of these flags was presented to the N.S.R.P. Color Unit and turned right

side up to again fly proudly with the THUNDERBOLT Banner. Sporadic fighting between the young Nationalists and the Jew - communists continued whenever they could break through the police lines to get the reds. Throughout it all not one single Jew nor non-White dared even touch the Flag of the THUNDERBOLT.

Hundreds of photographs were taken and scores of reporters interviewed the N.S.R.P. spokesman throughout the afternoon. The N.S.R.P. was

rated. A special tribute was paid to the N.S.R.P. delegates during the March as the Victory Rally leader, Dr. Carl McIntire, called the attention of the participants to view our Party Flags approaching the monument grounds as the most colorful flag unit in the parade. Another indication that it won't be long till the N.S.R.P. leads America to White Racial Victory.

Advice To NSRP Members At Large.

JAN 1971 THUNDERBOLT

While the National States Rights Party has a growing number of new Chapters around the country, a majority of our members are still in the "at large" category. They are affiliated with no Chapter because they do not live in one's vicinity.

It's easy to form a Chapter of the NSRP and members should write for details from NSRP Headquarters. But, the initial requirement is that a minimum of three members be enrolled in your local area.

It is therefore the task at hand for every "Member at Large" to be always on the alert for the possible recruitment of a convert. Let the following advice guide you in this important task.

1) Remember that you are an informal representative of the NSRP. Always maintain a clean cut appearance. Proper dress and a friendly attitude are very important.

2) It is impossible to win an argument or debate. Your opponent only becomes more strongly opposed to you when he has to defend his views.

3) The initial approach should be the mention of a selected number of subjects upon which we take a formal stand. Once a common mutual viewpoint is discovered, then expand upon it explaining the NSRP position.

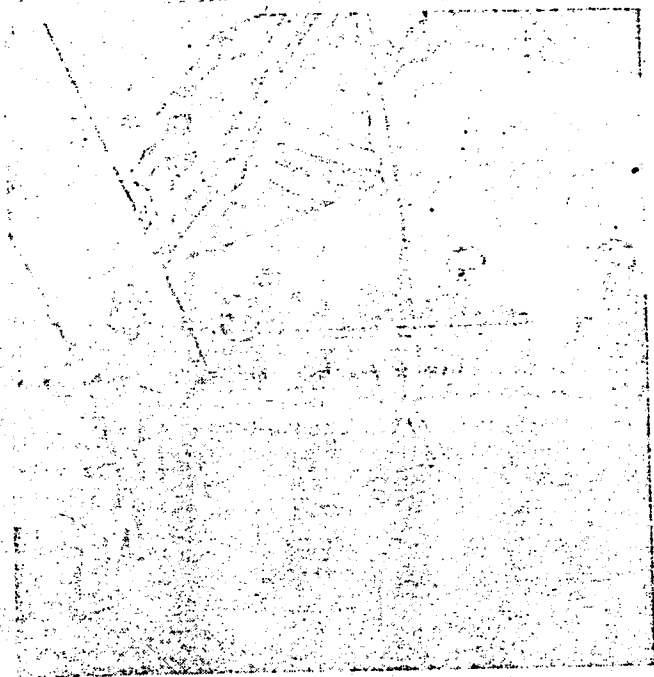
4) Discuss these subjects in a restrained, but authoritative manner. Be sure you know your subject thoroughly. Bring political questions up when conversing with neighbors, co-workers and sometimes it can be found more effective with total strangers. People you meet on the street, while shopping or in church.

5) Be selective and pick people who will become a credit to our movement. Do not waste time on those whom you deem beyond the call of our cause. Once you see the individual at hand is taking up too much of your time without making an affirmative decision for the Right, then switch your efforts to another prospect.

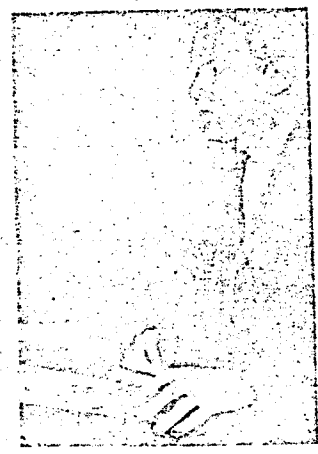
6) Avoid haphazard and diffused distribution of literature. Handing literature directly to a person can leave a lasting impression. When door to door distribution is used, two or three visits to the same neighborhood on successive weeks with different pieces of literature is often effective. Remember, middle working class neighborhoods are many times more effective than wealthy areas.

Always be on your best behavior and radiate the exemplification of the NSRP member. Honesty, integrity make one worthy of public confidence in a Party made up of superior persons dedicated to a righteous cause.

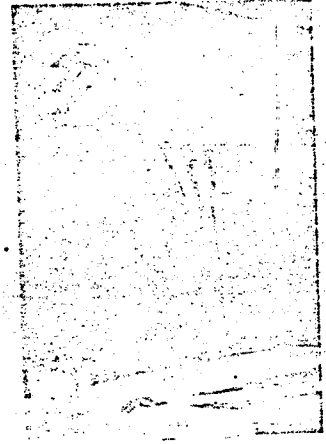

brother's death. But, the witness added, he never had reported that to anyone, "because it was none of my business." The guerrilla warfare expert continued:

"I just told him that I didn't need \$250,000 that much. It would have been nice money to have, but not for murder."

In his opening statement to the Fresno jury, Louise's counsel, DeVaney, said William Thoresen had told a man he hired to kill the former Green Beret that he (William) had "washed off Stoddard's body, stuffed it into a weighted sleeping bag and dumped it into the ocean." Thus informed, the killer was dispatched to San Francisco to ambush the ex-GI. But, for some reason, Thoresen report-

edly called the advertising man and warned him to stay away from the Thoresen apartment and the attempt on his life never actually was made.

The search for Stoddard's remains still is going on in the Bay area. San Francisco officers spent many days probing the basement of the Thoresen mansion with long steel rods, in the belief that there was a body buried down there. Now, they, too, have asked Attorney DeVaney for his files.

The one big question that is left is did the stuttering one-time gun czar have an accomplice when he dumped Stoddard's body in the murky waters of the Pacific, or was it all a massive fabri-

cation of a troubled mind on a bumper trip induced by LSD? Is Stoddard really dead and did he actually kill Richard Thoresen? Or did he just get as much money as possible from Thoresen and then depart for parts unknown?

One thing is certain—his police dossier had regular entries until they abruptly stopped in October, 1936, and no one has seen him since. Have you? If so, call Barton Collins, chief of detectives of the San Jose, California, police—now.

theater's annual popular "spook show."

A pretty girl, with dark hair and dark eyes, Pamela was a petite 5 feet, 3 inches tall, with an attractive 119-pound figure. She lived with her grandparents on College Avenue NE—seven blocks from where the young bride had been killed in her kitchen.

But that was seven blocks and six weeks away. And young people tend to think nothing will happen to them, and brush aside any words of caution. Besides, Pamela wasn't going to the movie alone: Her girlfriend, Louise Harvey, would be with her, Pamela told her grandmother. Louise and Pamela were good friends. They worked at the same laundry and Louise's father usually drove them to and from work each morning in his car.

It was a cool night in Grand Rapids. It might even be considered cold for other parts of the country. Still, the snow hadn't come yet. Pamela slipped into green and white striped pants, a dark brown sweater, a brown corduroy jacket. She left the house in time to catch the 8 P.M. show, figuring to be home by 11 P.M.

It was after 11 P.M. when her grandparents began to worry about Pamela. At 12, she had gone out with boys, but she'd said she was going to the movies and coming straight home. And she had to work the next day.

After waiting a while longer, they decided to call Louise Harvey. Maybe Pamela had gone home with her, they reasoned.

The call was made and a man answered the ring.

"Yes, Louise is here," he said. "Pamela? Why, no, she hasn't been here this evening. But she's not home. What can you tell us about her?"

"I don't know," the man said. "I'm Pamela's grandmother. She said she had to see Pamela that night."

"I was going to go to the movies with her, but she decided not to," the girl ex-

plained. "I don't know if she went with anyone or not."

Louise, worried, checked with Grand Rapids police. The grandparents of Pamela Jones also called — to report Pamela missing. Officers went to the home on College Avenue where they were given a description of the missing girl.

the news of the tragedy. He wasn't willing to talk with officers, though. They held a warrant charging him with burglarizing his father's home several weeks earlier. He and Richard allegedly had rifled the wall safe in the den, claiming their father had some embarrassing confidential records there. Richard had been free on bail on that charge, plus assorted others, including resisting arrest and assaulting police officers. The charges were withdrawn before the funeral.

That wasn't the only cooperative efforts of the brothers during Richard's last days. In August, Richard had prepared a new will in the office of William's attorney, a famed San Francisco legal lion, leaving the bulk of his estate—some \$370,000—to William, \$100,000 to Louise and \$20,000 to his nephew. (A superior court in Fresno, Cal., on December 7, 1970, named Louise Thoresen executrix of her late husband's estate, estimated to be worth \$400,000. Mrs. Thoresen is the principal beneficiary in her deceased husband's will.)

Most of the estate was either in cash or gilt-edged stocks, but it still took the lawyer more than three years to complete the probate action and Louise testified neither she nor her son ever saw a dime of their legacies. Reportedly, when William was alive he repeatedly had pointed out to his wife that he had spent "a lot of money" in her defense against the myriad of firearms charges that dogged their footsteps. (Mrs. Thoresen still has a federal probationary sentence to complete and a New York City trial date early this year on both felony and misdemeanor charges of violating the tough Sullivan law. In all the court troubles she maintained she was acting only as a courier for her husband.)

An interesting sidelight to that was revealed during the Fresno trial. Thoresen had applied for a federal machine gun dealer's license in 1965, which he was denied because of a six-year-old conviction in Bar Harbor, Me., for stealing travel posters from the wall of a ferry terminal. Mrs. Thoresen, according to one San Francisco-based Treasury agent, applied for the same license and she, too, was rejected, not because she never had been convicted of any crime, but because she was wed to the eccentric steel heir. The agent admitted Louise had pointed out to government officials that several gun dealers had been convicted of violating federal gun laws and their wives were then licensed. He said she was told that was true, but the "Huns" weren't going to get that kind

of September 21 to his luxury high-rise apartment on the shore of Lake Michigan. Louise told investigating officers she had waited for him at the apartment from Monday evening until 1:30 the following morning. Later on Tuesday, before the shooting had been discovered, she said she returned to the apartment and found her credit card, used to rent the car, on the kitchen table.

Meanwhile, Officer Bruno visited a gun shop in Waukegan, a town 20 miles north of Lake Forest on the lake. The owner, Calvin Grosse, said Richard first visited his store in July of that year and was with William. They bought two blank pistols, 200 rounds of .22 caliber blank ammunition and two magazines for M-1 carbines. As they paid for their purchases, they also picked up some spare parts for rifles and for an M-1.

Early in September, Grosse said, Richard came back to the store alone and bought a sophisticated, small-caliber, semi-automatic rifle—a Colt AR-15, .223-caliber, with a telescopic sight. Grosse told Bruno he had been out of ammunition for the expensive weapon, so he ordered 200 rounds for Richard, which he picked up on September 16. Two days later, Richard returned for a third visit, accompanied by Louise. They bought the Python later found on the floor of Richard's rented car. According to Grosse, the pair said Louise wanted the gun to take back home to Arizona for a household weapon, because her husband was out of town a great deal and she felt she needed some protection. They also purchased a .350 Walther's automatic. That was Saturday.

APPARENTLY the shopkeeper was the last person police have been able to find who saw the youth alive. He visited the gun shop at approximately 2:30 P.M. on the day before his body was found. In a lengthy conversation with the man, the younger Thoresen brother discussed shooting the Walther and showed the gunsmith how he was carrying it in his waistband. He said he had fired 29 rounds with it the previous day and had become so fascinated by the weapon that he wanted to return to Germany to visit the plant where it had been made. At the same time, he bought 100 rounds of Winchester .350 shells for the gun, a \$15 pipe for William's birthday or anniversary. (William and Louise were married on January 1, 1960; William's birthday was in the spring.)

One major part of the conversation that stood out in Grosse's mind was that the younger man was particularly proud of his ability to shoot a target 100 yards away. That is a major accomplishment for even competition target shooters. Grosse said he also was impressed by the fervor of Richard's apparent desire to go back

to Germany, from which he had only recently returned after an extended visit in Europe. Grosse said one thing bothered him when he heard Richard might have committed suicide: In their conversation just hours before the fatal shot was fired, Richard had not sounded like a man who would take his own life.

Both Sergeant Nelson and Officer Bruno also were bothered by that fact and by their failure to find the Winchester ammunition. The shells in the box under the car's front seat were .35 Remington specials.

When Coroner Clavey summoned a jury to hear the evidence in early October of 1965, they were unable to rule whether the death had been a suicide or a homicide. They specifically asked the Lake Forest police to continue their investigation. That apparently is being done, for the day Louise was freed of the charge of killing her husband, her attorney received a request for the entire defense file as it pertained to Richard's death. Much of it was Louise's own testimony of her conversation with William in the last hours before she emptied .35-caliber revolver into him. She said she and William had had a particularly bad day—he had beaten her regularly and brutally and then suddenly appeared calm and rational. She testified:

"We began to talk and I said, 'William, this can't go on like this anymore. Will you please follow the advice of Dr. Boyce [Dr. Lancy Boyce, a Fresno psychiatrist who testified Thoresen had consulted him, but was "too hot to handle" so he had prescribed hospitalization] and go into a hospital?'"

To her request, Louise said, William had replied, heatedly:

"Lou, I can't let them psych me. I do they'll find out I had Richard kill and then killed the guy who did it. . . he [Richard] wanted to do was help and with you and Michael [their young son] and me he finally belonged. . . killed the wrong people."

Louise sobbed to the eight-man, five woman jury:

"And all the time we thought Richard had taken his own life. . . God! Oh God! Oh my God!!"

Louise also said William had told her he felt his parents should have been killed instead.
