Dear Harold:

K-cars like yours and mine have excellent heaters. Your thermostat is surely worn out. It is made of a cheap spring and it gets"lazy" after a few thousand heat cycles. I had to replace one in my Chrysler.

Have a garage replace the thermostat with a new one, being sure to use the correct temp.= Also, while you are at it, replace your antifreeze. Makes the radiator last longer.

Also, have them check and fill the differential housing. It is a little hard to get to and unlike most cars, it is <u>not</u> filled from the transmission. Mine ran dry and I could hear it whine.
