Dear Harold and Lil:

I am amazed at how many auto dealers and tractor dealers forget that one. It was a ball buster. Our volume dropped \$100 million.

You know, John Sherman Cooper was one of our customers! His brother Dick and John owned Somerset Stone. Sold them a lot of rock crushers. And loaders.

It is snowing like hell! Maybe I can go home early, if the boss wasn't such a SOB!

Larry is getting better, but slowly. Im going to try to get upon there sometime this spring, but I don't know when. We are going to Chicago last weekend in March, Betsy's cousin is going to get married and it will be one of those social events of the year. One of the few times Betsy gets to see much of her family. I may go to Talladega- the racetrack, not the prison! - last weekend in April, since dad has tickets and I don't think Larry can go. I have to achieve a delicate balancebetween all my family obligations, and what I really want to do, which is come to Frederick. I never thought I would see the day when I would rather hang out with a 82 year old historian than go to a stock car race! Guess I have achieved middle age.

Plus, we have to see how Lil comes through surgery. I do not want in any way to disturb you two. Like the Pittsburgh article, you have written 10 books so far! So I'll just play it by ear. Southwest has cheap air fare to Baltimore, and that worked out great last year. Betsy thinks I am an idiot after some of our 50¢ tours of DC. The Baltimore airport is one of the most convenient I have ever been to. I only got lost once! Sheer terror seems to be the dominant emotion when I am let loose in the ocean with a 15 foot boat, 15 gallons of gas and a case of beer. Oh yea, of little faith!
