Dear Harold and Lil:

Enjoyed your letter and enclosures I got today. Glad you enjoyed my letter, I try to entertain and educate!

Interesting to see how Chip Selby and his proposed documentary come out. As far as people changing, I did some work for the father of an old girlfriend recently, well, about two years ago. I had not seen her for a while. She asked me"You haven't become one of those Rush Limbaugh Republican right wing idiots like half my other friends, have you?" I told her NO, I am still a liberal Democrat but probably more liberal now than even in college. She said"Thank God!"

I do think it is weird that people come to see you, just to argue with you. When I question you, it is not to convince you of my own -brilliance, but to get at the truth. As you know, the biggest arguments come from the know nothings.
