Dear Jane:

It has been two years since you have done a show on the assassination of President Kennedy. Since Nov. 22 falls on a Friday this year, I hope you consider doing one this year.

As I have told you, Harold Weisberg is the leading expert on the JFK case, as well as that of the murder of Martin Luther King. He has been in such documentaries as "Reasonable Doubt", "The Men Who Killed Kennedy", and discussed the King case on "Unsolved Mysteries".

I visited Harold in September, and though he is 84, he is sharp and retains an almost unbelievable memory. Various issues that you might wish to discuss include the news media almost totally ignoring the legitimate criticisms of the Warren Report. For example, Sen. Richard Russell of Georgia has stated that he felt JFK was killed in a plot, which means that the Warren Report was not unanimous. Russell was a member of the Warren Commission. Our Senator John Sherman Cooper felt that Oswald was guilty, but he and Russell disagreed that the so called "Magic Bullet" could have injured both JFK and Gov. Connally. In other words, the Warren Commission could not agree on how many bullets were fired.

In addition, President Lyndon Johnson told Walter Cronkite that he felt JFK was killed in a conspiracy.

I include some supporting documents, including a 1975 Freedom of Information Act lawsuit where the FBI admits that Weisberg knows more about the assassination investigation than they do!

Harold Weisberg currently has four books in commercial print. "Case Open", "Selections from Whitewash", and "Never Again!" discuss the JFK murder. "Martin Luther King: The Assassination" concerns the innocence of James Earl Ray, and is the only accurate book ever written on Dr. King's murder.
