## UK LIBRARY HAS RARE BOOKS ON PRESIDENT KENNEDY ASSASSINATION

You've seen the "X Files". Maybe you have seen a documentary on the murder of President Kennedy. But how would you like to see the most controversial picture ever taken on November 22, 1963?

This writer donated two sets of out of print books on the JFK assassination about three years ago. One set is in the library, the other is in Special Collections.

The books are by Harold Weisberg, author of over a dozen books on the murder of Jack Kennedy. Weisberg has done more than any one man or woman to get secret documents released from government control. He has sued the Federal government over a dozen times, and the result has been a release of over 250,000 pages of documents previously hidden from the American people.

So, what about that picture? Go to the library, and look up the Weisberg book "Whitewash II". It has the infamous Altgen's picture, taken at the precise moment of the President's limo receiving the first shots. And it appears that is Lee Harvey Oswald, standing in front of the Texas School Book Depository.

Oswald's fingerprints were not found on the rifle that was discovered in the building. All evidence indicates that he was in fact either on the ground floor or actually outside the building at the time of the murder.

It is Weisberg's opinion, shared by this writer, that it is in fact Lee Harvey Oswald standing in front of the building. The shirt he is wearing is identical to the one he was arrested in. But the picture reveals more.

In the Dal-Tex building, there appears to be a man possibly holding a rifle, directly under another man on a fire escape. The man on the fire escape was never interviewed or identified by the Warren Commission. In fact, all pictures of this shot in the Warren Report are cropped, so the fire escape does not appear.

The Warren Report remains controversial because so many of its conclusions were either false or unproven. In fact, the conclusion that Lee Harvey Oswald was guilty and acted alone is only a theory, not supported by fact. The Secret Service reported the sound of automatic gunfire from the Grassy Knoll. Abraham Zapruder, the most famous amateur filmmaker in history, was standing on the Grassy Knoll. He reported shots came from behind him.

In the last three years, Weisberg has published four books. "Case Open", "Selections from Whitewash", and "Never Again!" discuss the JFK case. "Martin Luther King: The Assassination" is a reprint of "Frameup". This is the only accurate book ever written on the murder of Dr. King.



There have been many books written on the JFK assassination, but only about fifteen or so are accurate. Sylvia Meagher's "Accessories After the Fact" is excellent. So is the incredibly hard to find "Presumed Guilty" by Howard Roffman. Along with Weisberg's books, these are the ones used by the few college professors in America who are subject matter experts. This writer, an attorney and historian (UK1975), is one of the few authorities on the JFK murder in Kentucky.

It is a sad fact, but most history departments in America scoff at those who have studied this subject. It is left to the realm of the so called "Radical Historians", who have proven more accurate than many in the mainstream. For example, Weisberg, a former Senate investigator, has insisted for years that the Gulf of Tonkin Incident, which led us into the Vietnam war, was staged by the U.S. Navy. Many college age and draft age students believed the same thing. Now that former Secretary of Defense Robert McNamara has admitted that the Navy apparently faked the event, who looks like a fool now, those critical of our deadly adventure in Asia, or the Navy?

Weisberg says we may never know who was behind the murder of President Kennedy. "The Warren Report was a poor job at best, and the assassination was never, and I repeat never, properly investigated."

So, take a few minutes, and look up "Whitewash II". It is believed that at one time, even the FBI thought the picture was Oswald. It looks like him. The shirt looks like his. And he worked in the building. And remember, all the evidence in the world is useless if tampered with. And then, go look up the picture in the Warren Report and see how it was cropped. Why? Well, you decide.

But look at it this way. If the Federal government lied to us about the Gulf of Tonkin, about Watergate, about the exposure of Gulf War vets to both chemical and biological weapons, does it ever tell us the truth? About anything?
