Dear Harold and Lil:

I thought to myself that I was lucky to be there with my brother Larry and dad. Now, Larry can't climb the stairs to the stand, and dad is too sick to go. Creeps me out! Makes me wonder if I am next. I feel fairly good, though!

Liked your comments on the Liberty ship. Now I know why they have sunk so many for artificial reefs off Florida! Not too much quality there. I think Henry Kaiser was turning out about 1 a day, as I recall.

I was very surprised that you had heard not the story about Navy pilots dropping bombs in the ocean off Vietnam towards the end of the war. I believe I heard about it on TV once, pilot said we killed lots of fish but at least we did not kill as many Vietnamese. Also have read it in popular news, perhaps Newsweek. Would make a good subject of a documentary.

I have never liked to compare the USA to Nazi Germany, but we came pretty close with napalming civilian populations.

Unsolved Mysteries had a story Friday night about possible Navy experiments with germ warfare on civilians. I note that Chip Selby still works on the show. Don't know if he worked on that story.

Hell, I've seen murders, suicide, coups, bankruptcy, insanity and theft in my life-- and that is just in the tractor business!

For example, I was offered the John Deere dealership in this areaall I would have had to do is borrow \$2million. Well, I told Betsy that I did not think that was a very good idea for a number of reasons, and that I thought the Deere people were nutty and unprofessional.

So, I opened this office. Some friends of mine became the Deere dealers. Now, 10 years later, Deere yanks their franchise and they aretied up in litigation. My friends spent 10 years busting their ass trying to improve Deere's market share, and they get kicked in the teeth as a result. Totally a screw job.

Thank God I stayed away from that one. Dad and I discussed it, and made the right choice to let him stay retired. I have tried to live my life by one rule-don't borrow \$2million! For anything! Because they expect you to pay it back. I can barely sleep at night as it is. But at least I don't have to figure out how to repay anything greater than my credit cards.

I am also highly disturbed by what may be another breakin at your house. I have told you before and I will tell you again, change your damn locks. Call the locksmith and have it done. It is just no t a good idea to leave yourself so vulnerable. Make it a challenge for them at least. Get some burglar alarm decals and put on your door, that will make them think twice.

With what is missing, I think we both know who might have been behind it. Intimidation, pure and simple. Like Rookstool sending you that picture holding the rifle.

I may be paranoid, but I still wonder about that Nov. 22 letter to you that disappeared, and the odd phone call the next day, almost 24 hours after you were on Jane NOrris' show. The one where no one was there, but I heard the song"Long Cool Woman in a Red Dress". You know, Jean Whatshername bills herself as "The Lady in Red." Jean Hill. And frankly, if I told that story to anyone but you, no one would even believe it happened, no matter what it was all about.

I have been debating what forum I want to be in when I make a speech on the JFK and MLK case this year, which is my main goal. I am going to propose to my friends in Legal Aid that we make it a fundraiser for Legal Aid or one of their subsidiaries. I'll let you know what happens.

I would want to show some short films, and introduce you by video to the audience. Then, I would make a bout a 45 minute speech on JFK, and then touch on Dr. King, RFK, and a little on Malcolm X.
