

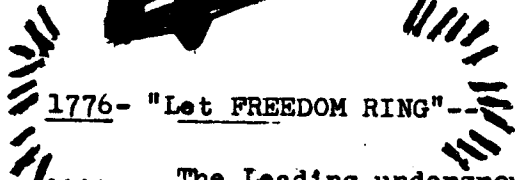

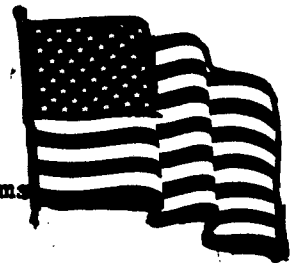

→ All the suits & Appeals have been evilly Dismissed & Denied in many cruel Courts SWINDLES to Pltfs. by DEFTS. aided by their corrupt "JUDGES"-
4. "IDENTITY REVEALED OF "FPF", firm Owner-President!"
→ A WWI war orphan, born Sept.1918 in Germany or France or ??--illegitimate daughter of Ernest Hemingway, great writer & WWI & WWII WAR HERO, from too, area of Chgo, Ill; & cousin to late, great writer & also our WWI & WWII WAR HERO-Colonel Robert R.
