I called Mr. Adamson, who has stretched the Kennedy conspiracy theories to include Mr. Zapuder, the late Dallas man who filmed the assassination. "I found it very unnatural that Alvin Zapuder doesn't blink or move while filming this. How does he know the bullet isn't coming at him?" Mr. Adamson asks. Thank you very much for the correspondence you have sent to my office recently. First, I want you to know that I appreciate the information you have provided me regarding the assassination of President John F. Kennedy. And, as you already know, I strongly support disclosing the records regarding the assassination. To this end I have cosponsored H.J. Res. 454, a joint resolution to provide for the expeditious disclosure of records relevant to the assassination of President John F. Kennedy. This resolution has been reported out, but has not yet been scheduled to come before the full House for consideration.

With reference to your inquiry as to whether I have referred the information you have given me to the appropriate Committees, I want you to know that I sit on the Committee on House Administration. This is one of the Committees that has jurisdiction over this issue. I have certainly kept the information that you have provided me in mind as we have discussed the issue. However, as I am sure you know, there are many people involved in the investigation. Ultimately, I believe that all information that is relevant will be extremely useful in the the investigation.

Again, thank you for contacting me. Please do not hesitate to let me know whenever I can be of help in my role as the United States Representative for this area.

And finally, in a column about the varied array of topics in the personal section of the classified ad, I mentioned Kennedy researcher Bruce Adamson.
