However, if you have any documentation for what you say, as distinguished from what you tried to do, I would like to see it.


For example, have you any way of identifying those you say used you as a courier?

I understand you are the Mr. Weisberg who authored the book, Coup d'etat In America. I can't find the book anywhere and they are careful not to let it in libraries. In Mexico City I was handed 4 photographs and 28 documents showing who was deployed to kill Pres. Kennedy. That is not the big story. The real story is the behavior of government vis-a-vis this evidence. The blatant law violations are unbelievable by those who have never experienced the brute force of government and the criminals therein.

I am seriously crippled as a result of torture in an effort to force me to sign untrue statements.

I have the matter in court but the court ignores my plea and I cannot find a lawyer who will touch the Kennedy affair.

I am age 68 and not long for this world. Do you know an author who would co-author a book, not so much about the killing, but about the cover up - from data in public records and or used to be in public records - the absence like footprints in sand.
