Could you please inform me as to which of your publications on the JFK assassination may still be in print and how I may go about ordering them?

I am interested particularly of course in the Whitewash series, but if there are others I would like to know of them also.

The James Earl Ray story is also of interest to me and I know you have studied this also, for I recall seeing a TV documentary in which you discussed this with regard to the MLK assassination.

Anything you may have on the RFK assassination would also be of interest.

My trouble is that I purchased the Warren Commission Report as soon as it was issued and believed it, hook, line and sinker. By the time I wised up it was too late to buy many of the early works. I own some twenty books on these horrendous events and have read at least thirty more borrowed from the library. Some, long out of print such as Josiah Thompson's "Six Seconds in Dallas", I would like to own, but do not know where to write in order to determine whether they may still be purchased used. Anything you may be able to tell me along these lines will be greatly appreciated.

Thank you for your most kind cooperation. Keep up the good work!! Many in this country admire you greatly, but of course few of these live in Washington, D.C.

Responding to your letter of September 24, I am enclosing a list of all the books which we have published. The prices listed are the by-mail prices. All of them are available from us, all but two in the original editions. Those two, WHIYEWASH: The Report on the Warren Report and OSWALD IN NEW ORLEANS, have been out of print for a number of years but we keep them available by xerox, WHITEWASH in the same size as the original and OSWALD in a larger size.

There is one book on the MLK/JER case which is the original edition.

All our books with the exception of the xerox editions we carry at their original prices, the only changes in cost being those occasioned by the increases in postage charges.

While you are trying to locate some credible books, you may want to include in your inquiries Sylvia Meagher's "Accessories After the Fact," which we understand has been reissued. Also, Howard Roffman's "Presumed Guilty," which is out of print and in rare instances a copy may be found. These are the only two of all the many which have been produced that we can recommend, and you will be very lucky if you can find them.

As possible sources, you may try Last Hurrah Bookshop, 937 Memorial Avenue, Williamsport, PA 17701; The President's Box Bookshop, P.O.Box 1255, Washington, DC 20013; Tom Davis Books, P.O.B. 1107, Aptos, CA 95001-1107.

All of these carry as many books as they can find in the field. All of them also carry our books.

You are not alone in having been taken in by the Warren Commission Report. Most people were so anxious to believe that they would have accepted anything which promised an answer.

I am replying to your letter because my husband is very busy working on another book and I try to relieve him of as much correspondence as possible.

Thank you most sincerely for your kind words about his work and the admiration with which he is regarded. We can only hope that he will be able to complete his work before he has to retire.
