SUMMARY OF EXPERIENCE:

Twenty-three years military experience at U.S. Army levels from AC of S, G2, Dept. of the Army to Military Intelligence (MI) operational field units. Experience ranged in Area Intelligence, Counterintelligence and Combat Intelligence. Duties in these areas were as Special Agent, Technical Specialist Staff Officer, Investigation Planning and Control Officer, special operations, research and development and polygraph activities.

July 1972 - May 1973 - Director, Psychophysometric Division, Dektor Counterintelligence and Security, Inc., 5508 Port Royal Rd., Springfield, Va. 22151- Presented sales demonstrations of the Psychological Stress Evaluator (PSE-1) to many varied groups across the nation. Instructor, Psychological Stress Evaluator Orientation Course.

Sept. 1959 - Jan. 1961 - Chief of Polygraph Division and Assistant Chief, Security Division, Hqs., 112th MI Group, Ft. Sam Houston, Texas. Was responsible for the planning and supervision of all polygraph activities of polygraph examiners assigned to that group. Actively conducted special polygraph examinations as required. Was staff advisor to the Group Staff and Fourth U.S. Army Staff on all polygraph matters and special security matters. Gave security presentations in all major posts in the Fourth U.S. Army area and conducted special investigations as required by the Group Commander.

July 1957 - Aug. 1959 - Chief Polygraph Examiner, 66th MI Group, Stuttgart, West Germany. Was responsible for the planning and execution of the polygraph activities of polygraph examiners assigned to the Group. Conducted annual polygraph seminars for Group polygraph examiners and invited guests. Was Polygraph Staff Advisor to the Group Staff and the G-2, USAREUR on related matters. Was responsible for research into the Lodge Act Alien Enlistment Program which ultimately caused the termination of the recruitment of aliens under that program.

Feb. 1956 - July 1957 - Team Chief and Assistant Operations Officer, 8th MI Company. Was responsible for the investigative activities of six Special Agents operating in the 8th U.S. Army Division. Was the Security Staff Advisor to the Division Staff. Directed and conducted security surveys and inspections, presented security lectures as required by the Company and Division Commanders.

July 1953 - Jan. 1956 - Chief, Photo Division and Special Agent, Polygraph Examiner, Hqs. 902d MI Group, Ft. Holabird, Maryland. Supervised and performed intelligence and investigative photography assignments as necessary. Functioned as a member of a special surveillance team and performed special investigative assignments as necessary to the completion of the Group's mission. Successfully completed training in Defense Against Methods of Entry and Basic Polygraph Course during this assignment. Subsequent to the polygraph course, duty assignment was as an intelligence polygraph examiner.

July 1951 - June 1953 - Chief, Special Investigations Team, Region I, 66th CIC Group, Stuttgart, West Germany. Was responsible for the planning, coordination of investigative activity of 30 Special Agents, Liaison Officer between French Forces in South Germany and the 66th MI Group and a staff officer of the Region. Activities of the team included security surveys and inspections, surveillance of persons whose activities appeared to be inimical to the U.S. and/or U.S. Forces in Europe, background investigations, screening of displaced persons for migration to the U.S., liaison with German government officials on local and state levels and specific investigations involving suspected espionage, sabotage, treason, sedition and disaffection.

Mar. 1950 - May 1951 - Chief of Photo Division Hqs., 66th CIC Group, Stuttgart, Germany. Was responsible for the intelligence and investigative photography efforts of eighteen photography specialists assigned to the Hqs. and Regions of the 66th CIC Group.

Apr. 1949 - Feb. 1950 - Casual and Student. Spent time in administrative processing, basic CIC Special Agent Course, Intelligence and Investigative, Photography Course, Basic German Language Course, and awaiting completion of background investigation.

Sept. 1945 - Mar. 1949 - Commanding Officer, Medical Squadron, 14th Air Force Hospital Mess Officer, Dietician Registrar, Hospital Fund Officer; the responsibilities of these duties ranged from the administration necessary for 150 enlisted men and women and the handling of funds from 20 to 100 thousand dollars per month.
