

Dear Harold:

12 June 1998

Just got home from Boise, Idaho to find a package and a pair of letters from you. I will answer them in sequence. Your 6/3/98 note accompanied chapters 25 and 26 of the Posner critique. The note indicated a potential for repetition and a request that I note it. I shall do just that. I have had the chance to read chapters nine through thirteen while I was away in Boise and I am struck by how much time you spent on Hoover's propaganda mill activities. That is an area of knowledge that I have not been previously made aware. What a corruption of the role of government if there ever was any.

Far from being taxing, I am actually enjoying the work of retyping your manuscripts. This evening I spent time retyping chapter nine. When I come to chapter thirteen I will be taking the original documents that you wished to be scanned and I will be including them in the text. My new scanner can scan the original; re-orient the page so that the image is square with the page and remove the photocopier speckling and page edge effects to a fair degree while preserving the integrity of the original document image. I hope you will be pleased with the results. On Monday, I will be contacting Professor Wrone through the Internet to forward electronically the results of my retyping work chapter by chapter to speed the results along. He indicated that he was concerned with your health the last time he met with you and indicated there was a great need to move quickly on this job. Thus, I am working full tilt to see that he gets the work as rapidly as possible.

With regard to your 7/7/98 note, I think the title is a little long though it may reflect the nature of Posner's work accurately. I am now in letter contact with Neichter he sent me a note suggesting that a small group of people that believe that Harold Weisberg is 99% on the money relative to the JFK assassination and are friends with you are called "Weisbergians." He included Professor Wrone, Professor McKnight, Professor Giocchio, Professor Macdonald, and himself. Then went on to include me in this esteemed group of Weisberg supporters. I would not diminish it by calling it a cult or a fan club, but I will say that you appear to have a loyal following that will carry your work and your memory well into the future. You have certainly effected all of us in one way or another for the good. I believe that America will only recognize the strength of your work long after it is too late to honor you for it with an accreditation of your work the day after the truth is known about the JFK assassination.

With regard to puzzling through the Posner manuscript, I have a lot to learn and I see you are the just the person to teach me.

It might interest you that I found a copy of *Oswald in New Orleans* in a bookstore in Nampa, ID a town fifteen minutes west of Boise. It was in decent condition and I was able to get it for only \$1.95 plus tax. What a steal.

I have to get back to retyping your Chapter 10 so I will end here. I hope to have Chapters 10, 11, and 12 done for Professor Wrone's potential receipt over the Internet on Monday.

I hope you and Lil' are in the best of health.
