I, George de Mohrenschildt bought 46 one hundred dollar American Express Travelers checks with a check on my account 684-3734 at Oak Cliff Bank and Trust Company. The numbers of the checks were RB 43-386- 804 to 849. This was done on Febr. 24, 1977 and I have the receipt. Then Willem Oltmans drove my car from Dallas to Houston. The ticket from Houston to Holland was paid by Willem Oltmans or Carl Engelaers (?) supposedly of the Dutch Television. The purpose of the trip was to discuss eventual TV appearances, a book on Lee Harvey Oswald and my friendship with him.

David Russell, friend of W. Oltmans with domicile in Houston, 2020 Huldy Street No. 8, tel. 703- 522- 7434 promised to take care of my car and signed a receipt which I have. I gave him the insurance card. Arrived in Holland with Oltmans and stayed with him at Amerbos 205, Amsterdam. Noticed that the house was registered in the name of his boy-friend Van de Wouw. Oltmans also has a residence in New York, Kew Gardens and his car has a New York license.

Immediately, we had a meeting with Gerald Croisette at his home. He is supposed to be a clairvoyant who had connected my name with Oswald. Present also was Karl Engelaer of Dutch TV (?). We also had a meeting next day with Mr. H. Janssen of Stranghold publications. This publishing company wanted to give me a contract for a sensational book re. Oswald and my influence on him.
